State Crop Prospects.

WILLAMETTE VALLEY. Albany, Lane county, C. L. Shaw.—Very little seeding done so far this spring; ground still too wet. Winter wheat and oats making good growth, but winter wheat has been more or less injured by cold rains. Prunes promise about one-fourth of a crop. Scarcely any Bartlett pears.

SPRINGFIELD, Lane county, J. S. Churchill.—The week has been warm and showery, forcing a strong growth of vegetation. All crops doing well, except those on wet land. There will be a very short crop of Italian prunes and Baldwin apples. Garden vegetables growing finely. Mops doing well.

WESTON, Umatilla county, Jas. Kirkpatrick.—This week has been very favorable for all kinds of growing crops and garden; the weather has been warm, with occasional showers. Fall-sown wheat will mature and be a fair crop if we do not have any more rain.

BAKE OVEN, Wasco county, H. Eichenberger.—The weather has been very favorable to crop; warm, with heavy showers. Spring grain taking rapid growth; grass fine. Prunes, plums, and cherries in bloom. Potatoes all planted.

MYRTLE POINT, Coos county, L. Strong.—The weather during the last few days has been fair; ground rather wet for farming, owing to previous rains. Farmers are behind with their work; grass and all vegetation growing nicely; fruit and berries very promising; creameries and dairies running on a full supply of milk.

Talent, Jackson county, Geo. Alford.—The week has been pleasant. Thunder-shower, Wednesday followed by partly cloudy weather. Grass and grain growing nicely. Fruit and gardens all planted. Fruit prospects are good, owing to progress in growth. Alfalfa has made good growth and will be ready to cut in about three weeks.

ISLAND CITY, Union county, J. M. McCall.—The past week was a trial one from the farmers' standpoint. Portions of the valley had the heaviest rain of the 6th for the past year. The weather being warm, vegetation of all kinds has made a good growth. Orchards are turning white, and if not injured later, this valley will have a heavy fruit crop. Sugar beets coming up nicely; fall wheat looking well; spring-corn improving; warm and cloudy today (the 10th).
