

PENALTY FOR SETTING FIRES.

Governor Geer Issues Annual Proclamation on the Subject.

SALEM, July 29.—Governor Geer has issued his annual proclamation warning against setting fires that may spread to timber, fences or crops. The law on the subject provides a fine of \$20 to \$1000 or imprisonment for terms from twelve months for maliciously setting a fire which shall destroy the buildings, crops, fences or timber of another. If the fire be set without malice and yet destroy such property, the person setting the fire is liable to a fine of \$10 to \$100. Any person setting fire to a wooded country or forest owned by the United States is liable to a fine of \$1000, or imprisonment. In all cases one-half of the fine is paid to the person who first furnishes the information to the district attorney.
