

Wireless News Reports.

The first regular daily newspaper in the world depending entirely on wireless telegraphy for its general news service was launched Monday morning at Avalon, Catalina Island, twenty-five miles out in the Pacific Ocean.

The Pacific wireless telegraph company has been doing a commercial business from the island successfully for a number of weeks past, numerous dispatches being sent daily and from the island. Previously the only method of communication was by mail.

The new paper is called the Wireless, and is published under the auspices of the Los Angeles Times, from the office of which an edition of the news was telegraphed.

Hereafter, the news of the world has not reached the island until the arrival of a steamer at 1 p. m. The system of the Pacific wireless telegraph company is entirely distinct and different from the Marconi system.

There was a heavy storm in progress when the news dispatches were sent to the island, but they were delivered promptly and without difficulty.
