 Now, before proceeding any further, I will make this proposition to you: Rather than cause all of these applicants to be put to the inconvenience and extra expense of republishing their notices—which no doubt they would have to do—how would it suit you to "divide up" the ad. fee of these 12 notices and you go ahead and complete the work. In that event, I would expect \$40.00, as that is one-half of the regular adv. fee of \$80—the amount each applicant paid.

 In answer we state: The notices were handed in to this office for publication before the Myrtle Creek Mail commenced publication or even before Mr. Shutt bought the Glendale News. But right here we desire to say to Mr. Shutt, if the publications in the PLAINDEALER should be adjudged illegal, what kind of a genus homo is the editor of the Glendale News when he, for sixty dollars, would assist in an illegal act? THAT PORTAGE RAILROAD.
 The Portland Telegram of Tuesday says:
 "A large part of Oregon, both territory and in point of population, including Portland, want the portage railroad built, for well known reasons, but it seems the railroad managers intend, if possible, to deprive the state, and the people whom the road would benefit, of that improvement. But the time may not be far distant when the railroad managers will learn that they are not entire masters of Oregon, nor even of every going Portland."

Why should every farmer, miner and business man in the state be forced to pay toll to Portland's commercial enterprises? If Portland wants the Portage Railroad let that city pay for it. Whenever legislation is needed for any part of Oregon and the Malheur delegation cannot make capital or graft out of it the relief measure is shut down on by the Portland grafters. Why should the citizens of the state not interested in Portland's speculations be forced to be placed as antagonistic to the various railroads running into Oregon? Why should the state try to depreciate the value of rail-

road property now paying taxes and at the same time collect taxes from the railroads and use the taxes to injure the property by building up a rival concern?
 If reports are true the accidental shooting of Mrs. Anderson at Cottage Grove should be thoroughly investigated.
 There are too many accidental cases of shooting wives in Oregon, and if the next fellow who accidentally shot his wife had his neck accidentally broken in the penitentiary, there would be fewer accidental shootings to record.

A Sweeping Defeat.
 This is to announce to the world, more especially to the fraternal organization of Roseburg, that Roseburg Lodge No. 16, A. O. U. W., has organized a base ball team composed of the fastest aggregation of sphere jugglers that ever knocked a knob out of a center-field fence with a swat of the horseshoe on the round side. In connection with this modest self introduction we challenge any fraternal organization in Roseburg to a game of ball for \$100,000 a side more or less. There is a certain lodge in Roseburg with whom we desire to cross willows, but whose name we do not care to mention, but we understand the Woodmen of the World have also organized a base ball team. It is needless to say that so far the order has not been complied with by a single conductor and a number of them have sent word to the officials that they will not endanger their lives riding in an engine cab, where in case of an accident it is a miracle if two men can save their lives, and where a third will make the chance of escape more difficult. HOTEL LEASED.

Mrs. Naghel will personally supervise the sleeping and eating department, and Ed will look after the welfare of the guests upon their arrival, and this itself will make the Overland famous, as Ed always has a happy greeting, good word and a new story for all. Mr. Hull will succeed Mr. Naghel as night clerk at the McClallen.

American Lake Selected.
 A dispatch from Tacoma says: General Frederick Funston has notified the secretary of the Chamber of Commerce of Tacoma that he has selected the site at American Lake near Tacoma for the encampment of 10 regulars and the National Guard of Washington, Idaho and Oregon. The Chamber of Commerce will secure the permission of the owners for the necessary land required for maneuvers. Between 4000 and 5000 men will be in the encampment which will be early next fall.

First Train Over New Road.
 The first regular train on the new scenic Klamath River Railroad started from Lairds, a station on the Southern Pacific at about 3 o'clock p. m. last Thursday, and arrived at the temporary terminus, a point two miles east of Pokagon, at 5 o'clock. The distance is 30 miles, and, considering that it is all up grade, that there are two switch banks, and a part of the newly laid track is not yet ballasted, the run was made in very good time. Judge Benson, who was passenger, informed us that the passenger coaches had not yet arrived, but they were looking for them every day. The passengers rode on a flat car, and Mr. Benson says even that it is so much superior to staging it, as a Pullman coach is to a flat car. A crew of men is still working on the track, and they are also building a branch road northward through the timber. Improvements are being made on the Klamath Falls wagon road. R. W. Marple, proprietor of the Western stage line, is perfecting arrangements with Hervey Lindley, president of the railroad company, and a regular schedule will soon be out. The drive from Klamath Falls to the station this side Pokagon, and distance about 33 miles, can be made easily in five hours, and the run down from there to Laird ought to be made in one and a half hours, thus affording quicker and cheaper transportation—Klamath Falls Republican.

"Fans"
 The Albany Herald, dubs the Roseburg base ball team the "Blossoms" and says:
 Several causes are assigned for top heavy score that footed up in Roseburg's favor, but the easiest way out of it is just to acknowledge defeat and let it go at that.
