OF INTEREST TO THE FARMER

The Times reports that the condensery at Forest Grove, Ore., shipped 32 carloads of condensed milk in October. Shipments of good apples to San Francisco from Oregon and Colorado have been too free of late and prices are lower in that city.

L. A. Marsters, a well known Angora breeder of Douglas county, Oregon, has moved to Meriin, Josephine county in order to secure larger range for his growing flock. He finds the conditions apparently favorable for goats at his new home.

I. A. Dean, Riddle, Oregon, says, "I now have a fine lot of goats and they are doing well. Have recently purchased some thoroughbred does and bucks of B. W. S. Folk of Glendale, Minnesota. There are several persons beginning in the industry in this section."

As turkeys are rather scarce and higher than usual in the middle west this year there is no danger that prices on the Coast will be hurt by importations from the East. Unless the turkey crop in the Coast states is much larger than usual this will be another year of good prices for turkeys.

The shipment to St. Louis of the apples exhibited at the Hood River Fair is enabling Oregon to go through the closing weeks of the World's Fair with a display of apples of unrivaled beauty and quality. Hood River apples will be better known than ever.

W. A. Coughlanor, of Fayette, Idaho, will exhibit his monster steer, Bolger, at the Lewis and Clark Fair. Bolger is between seven and eight years old, and the last time he was on the scales he weighed 3130 pounds.

The production of eggs on the Pacific coast does not appear to be increasing as fast as the demand. The receipts of Eastern eggs at San Francisco this year up to October 31, amounted to 31,120 cases, compared with 22,418 cases for the same time last year.

Rev. F. Walden reports in The Ranch that Spitzbergen apples have yielded enormously in the Yakima valley this year. One of his neighbors had a crop of 1200 boxes an acre of Spitzbergen and sold at one dollar per box, buyer furnishing boxes and paying for picking.

To show what is possible to raise in the Grand Ronde valley, Oregon, John McAllister reports that he this year secured 20 tons of alfalfa hay from three acres. From one acre he harvested 43,000 pounds of onions. His neighbor, A. F. Davis, harvested fifty tons of carrots from two acres. As bearing on the value of the alfalfa crop it may be noted that alfalfa hay is now selling at interior points in Eastern Oregon at \$10 per ton.

HOT TIME IN THE FLORENCE COUNCIL

FLORENCE, Or., Nov. 18.—The city council held an adjourned meeting last night and had a stormy session. It seems that the school district lacked some \$500 or more of being able to pay for the school house. At the regular session in October an ordinance was passed donating \$500 of city funds to the building fund of the school district.

U. W. Hurd, as president of the board, vetoed the ordinance on the ground that the council had no legal right to appropriate city funds to the school district. The council then voted on the ordinance again, three of them voting for it and one against.

At the council meeting last night Councilman Belkne asked the chairman if he would sign a warrant for the money and was informed that he had already stated in writing his objections to the ordinance, and that the same objections would hold against signing the warrant. Councilman Hughes then preferred charges against President Hurd, charging him with malfeasance in office. They then put Councilman Morris in as temporary chairman, then voted that the office of president of the board be declared vacant. They then appointed Marion Morris as president of the board. Mr. Hurd said he would retire and the recorder, A. E. Pichel, picked up his papers and started to lock them up, but the marshal prevented him from doing it and the recorder, Councilman Carman and ex-President Hurd then walked out. Marion Morris was then sworn in as president of the board and D. E. Severy was appointed and sworn in as recorder. Having thus summarily disposed of all opposition, the council then proceeded to transact their business in a very harmonious manner.
