**REPORT FROM
W.C.T.U. CONVENTION**

Mrs. A. C. Marsters, who is just home from the big International W. C. T. U. convention at Los Angeles, thus tells of the fine time, as follows:

A special car left Portland Monday evening, Oct. 23rd, bearing about thirty white ribbons from Washington and Oregon. As they came up the line to Albany, Mrs. Henrietta Brown, state correspondent joined the party and at Roseburg, Mrs. A. C. Marsters, State Rec. Sec'y, and Mrs. Mattie Graves, National Organizer, of the W. C. T. U., others getting on at Grants Pass. Our car attracted a great deal of attention, with the white ribbon streamers. We were met by the white ribboners at Ashland and a short service was held on the platform. Praise services were held on the car each day, but Wednesday evening was the crowning service. After Northern California delegation boarded our train and crowded our coach until there was no standing room for more, there were recitations, speeches and songs of praise until a late hour when they were obliged to disperse for the night. The San Diego W. C. T. U. entertained thirty-one at the home like hotel, Portsmouth. The State Sec'y, and Treasurer had the pleasure of being among that number. Here every want was gratified.

We arrived at Los Angeles Thursday morning. The convention proper, did not open until Wednesday, so we enjoyed a trip to Long Beach in the afternoon. In the evening a large reception was given to the visitors and members of convention, at The Temperance Temple. A nice program was rendered and refreshments served. Wednesday morning the largest delegation ever known in the history of the National W. C. T. U., came together in the beautiful Congregational church.

The convention was a great treat and inspiration, but to any mind the most touching and appealing service was the Sunday School Rally on Sunday afternoon, conducted by Mrs. Stella B. Irvine, National Supt.. There were standard bearers representing the different Sunday schools of the city. It was held in the First M. E. church, having two-thousand enrolled in its Sunday school and has a temperance lesson every month. The convention closed on Wednesday evening with great enthusiasm.

With a large party of white ribbons from New York, New Jersey and several other states, we left Los Angeles on Friday morning early, at Santa Barbara we stopped for a few hours, to see this great old city of the coast. To our surprise, we were met by white ribboners with flowers, who invited us to come up to the Unity church, where a banquet was prepared and 150 plates were laid. Our train left here at eight o'clock, arriving at San Jose. We stopped for a few hours and took the train for Palo Alto, where we visited the great Stanford University and then on to San Francisco where we spent Sunday and Monday. Mrs. Marsters arrived home, accompanied by Hon. and Mrs. F. T. McWhirter and daughter, Susie, of Indianapolis, Indiana, who will visit in Roseburg for a few days.

The W. C. T. U. will give Mrs. McWhirter a reception Friday afternoon, at Mrs. H. L. Marsters.

Mrs. McWhirter is editor of the Indiana State paper and also President of the National Editorial Association.

Mr. McWhirter is treasurer of the National Prohibition Party, and was candidate for governor on that ticket, at the last election. He will speak in the M. E. Church on Friday evening, Nov. 10th. All are cordially invited. X.
