**THE BUTLER-POMEROY LIBEL SUIT**

Correspondence Between the Parties.

The following correspondence explains itself:

M. M. Pomeroy, Editor La Crosse Democrat, Wisconsin:

SIR—When in Milwaukee last October I made all arrangements with parties there toward the prosecution of the suit I have brought against you for defamation of character, as per preliminary notification and summons. This was the principal object I had in visiting Wisconsin, and my work was done well. On consultation with a few friends I have decided to withdraw the suit if you will agree to stop your personal attack on me as a man and officer, which have so often appeared in your paper, the La Crosse Democrat. I have no particular desire or need to collect of you the amount claimed (\$100,000,) but do wish to have your annoying articles stopped, and if you do not accede to this proposition the law must take its course.

SIR—Your note is before me by to-day's mail and duly noted.
