The Sole Reason for Impeachment. The New York Tribune, in an article on impeachment says: The president is determined that the southern states shall return into the union with governments created by and recognizing the white vote only, while congress has resolved to confer the suffrage on both the black and white races, and to readmit the states only on the basis of impartial suffrage and loyal supremacy. This antagonism, in the fundamental problem of reconstruction, is the fountain and source of the whole difficulty between the president and congress.

This, is the clearest summing up of the matter we have seen anywhere. The President of the United States is to be removed by these fellows because he will not aid them in establishing a negro empire over one third of our country.—They know their funeral is appointed for the day the South is restored to its rights upon a white basis; and when the first election there after shall have transpired the corpse will be ready.

Democracy to the Rescue. "Constitutional liberty," in the glowing words of Justice Story, "must perish, if there be not that vital spirit in the people which alone can nourish, sustain and direct all its movements. It is in vain that statesmen shall form plans of government, in which the beauty and harmony of a republic shall be built upon solid structure and adorned by every useful ornament, if the inhabitants suffer the silent power of time to delapidate its walls or crumble its many supporters into dust. If the assaults from without are never resisted, and the rottenness and mining from within are never guarded against, who can preserve the rights and liberties of the people when they shall be abandoned by themselves? Who shall keep watch in the temple when the watchmen sleep at their posts? Who shall call upon the people to redeem their possessions and revive the republic, when their own hands have deliberately and corruptly surrendered them to the oppressor, and have built the prisons or dug the graves of their own friends?

Wendel Phillips says, after the President is put out of the way, all the property of the South must be seized and equally divided among the negroes. —A lot of boys in New York city, or gauged as a base ball club, have been arrested by Kennedy as being members of the "Ku klux klan." Now this terrible word, Ku klux klan will hang before the eyes of all sorts of sneaks, cowards and rascals like a thousand goblins. Whisper Ku klux klan in a Mongrel's ear and he will shake like a sick dog. It is an awful word which is destined to frighten to death all the fools and rascals in the United States.

—Senator Sherman admits that the expenses of the army for the current year will not be less than one hundred and twenty-three millions of dollars. A nice sum to be taken from the people, for the army in times of peace.

—The Ledger has discontinued the early life of Grant, by his father. It made out the boy to be such a rascal, and brute that even Grant was himself ashamed of his own boyhood.

—The Rev. George H. Heworth, of Boston, preached a late sermon on the "absolute righteousness of the impeachment." We advise his hearers to keep an eye on their spoons and daughters.

The Herald's Sensation Story.

The New York Herald's special correspondent at Washington, reports that there is a radical conspiracy on foot to extend the term of the President to ten years, strip the Supreme Court of its power to pass upon the constitutionality of any act of Congress, elect Grant in doubtful States by the bayonet, and an unlimited inflation of the currency by the National Banks. The radical papers pronounce this a sensation story, but it is true in part if not in its entirety. The radical leaders have been engaged in a grand conspiracy against the Constitution, the States and the liberties of the people for years. Their reconstruction policy is the result of a conspiracy to destroy the rights of the States and perpetrate their own power by unconstitutional means. They have no power over the suffrage question whatever, yet they are regulating it in ten States of the Union at the point of the bayonet. They have ignored the Constitution in their insane thirst for power, and are engaged in a crusade against the rights of the people. Their determination to strip the Supreme Court of all power to pass upon the acts of Congress, is no secret, certainly, and that they intend to carry the next Presidential election anyhow—by foul means if necessary—surely no one with the history of that party before him can doubt. Absorbed and controlled as they are by an inordinate thirst for power and plunder, the same motive which impels them to elect their candidate for the Presidency by unfair means will influence them to extend his term of office to ten years if necessary. The report to the Herald is not unreasonable. Indeed it is what may be expected under the circumstances. The impeachment and removal of President Johnson is a part of the grand conspiracy. They must have complete control of the Government to enable them to perfect and carry out their treasonable designs without interruption. With Ben Wade in the Presidential Chair, they feel that no obstacle will be thrown in their way, but on the contrary, all the power of the Government will be used to carry their plans to a successful issue. When Wade tauntingly told the people of Ohio, during the campaign last fall, that they would be compelled to accept negro suffrage, whether they liked it or not, he made no idle boast. When he becomes President, Congress will pass an act conferring the right of suffrage on the negroes in all the States, and if the people murmur, Gen. Grant will be ready with the regular army and the Grand Army of the Republic to butcher them for their audacity. This conspiracy reported by the Herald is no new affair. It has been in existence a long while, and has gradually been developed as occasion required or circumstances justified. A few months more will show the people what is in store for them.

During the late Ohio election, when Ben Wade saw that the Germans were about to vote the Democratic ticket, he declared in one of his speeches "that the negroes have more brains than the Germans and are more fit to exercise the privilege of voting than Germans."

We are sorry to hear that little Johnny Humason son of Hon. O. Humason, of the Dalles is no more. He died on the 7th inst, of an ulcer of the lungs. We remember little Johnny as a lively promising boy. We tender to the bereaved parents and relatives our heart felt sympathy.

What is a Radical.

A little boy asked his father the question, what is a radical? The "old man" undertook to explain the conundrum as follows: "A radical is a rapacious animal of the genus homo a native of the New England states; but occasionally found in the middle and western states; a satanic spawn of Puritan parentage; conceived in sin; born in iniquity; nursed at the breast of jealousy and self esteem; rocked in the cradle of prejudice and intolerance; educated in the school of low cunning and foul play, and lives by public and private plunder."

"Now my son, since I have defined radical, let me hear you parse it." Answer: "Radical is a unconstititutional noun, black in person, declining in number, African gender and deperat case; governed by the bigger accending to Puritan—one ignorantus governs another." "That will do, my son; catch your soul and take a wife."
