



Circumstances over which I have no control compel the abandonment of my newspaper enterprise. I regret, but cannot prevent this result.

It is foreign to my present purpose to discuss the causes of this failure, but it is my Fork. intention to so conduct myself as to ward off the effect it might have apon my future prospects;

There is more or less prejudice against him who makes an unsuccessful attempt in the newspaper business, and such failure is too commonly laid at the wrong door.

A newspaper-breakdown does not of he cessity result from lack of ability. The cessation of a journalistic enterprise does not always spring from bad management. Ben nett, the N. Y. Herald man, failed several times prior to succeeding as a journalist. Henry J. Raymond and Charles F. Dana each had their "ups and downs." And the newspaper failures of the notorious propri-etor of the La Crosse Democrat, furnish another standing illustration of the fact that such faileres are not always chargeable to bad management, or to want of ability. I might give many other well-known exam ples, in which persons of acknowledged abilty have been driven to abandon newspaper
