Fifteen Sticks of Explosive Found by Police in Vacant Lot.

BEGINS SUIT FOR BIG INSURANCE

Port Blakeley Mill Company Seeks Payment of Its Policies.

Tacoma, Wash., Oct. 8.—Thirty-one suits have been filed by the Port Blakeley Mill company and Detroit Trust company against the Insurance company of North America, the German Insurance company, Phenix Insurance company of Brooklyn, the Royal of Liverpool, the Phoenix of Hartford, North British and Mercantile, Hartford Fire Insurance, Royal Exchange, Scottish Union and National Phoenix Assurance company, Northern Insurance of London, Springfield Fire and Marine Insurance company, Connecticut Fire Insurance company and London and Lancashire Fire Insurance company. The thirty-one cases involve a total of \$221,000, being unpaid claims demanded by the plaintiff for losses caused by fire, which destroyed the Port Blakeley mills last January. The suits have been docketed in the superior court of Kitsap county, and the local agents of the respective companies have been served with a process.

The complaint of the Port Blakeley company and Detroit Trust company, as mortgagees of property destroyed by fire, does not set forth matters at variance between the insurance companies and the plaintiffs. It is merely alleged that the companies have refused payment of loss.

NAVY'S ACTION IS NOT APPROVED

Clash with the Department of Commerce Over Customs Duties.

Port Townsend, Wash., Oct. 8.—A test of supremacy between the navy and labor and commerce departments will be given when a decision is reached in the case of the British tramp steamship Netherlee, which reached port this afternoon, seventy-eight days out from Norfolk, Va., laden with coal for the navy and consigned to the Bremerton yard. When the vessel was chartered by the navy department for the trip the owners in England reduced the price of the service on the assurance of the department that the vessel would be exempt from all customs dues. Today, however, it developed that the bureau of navigation of the labor and commerce department is sole authority in matters of this kind, with the result that Collector Harper refused to enter the vessel and issue a permit to discharge until she paid the \$1 tonnage tax, which in the case of the Netherlee requires an advance of \$2,746.

Captain Rankin produced his charter in support of his refusal to pay, but the customs officials were obdurate, with the result that a large shipment of special steaming coal for the use of the Pacific squadron is now held up here. Customs officials referred the matter at once to the bureau of navigation, while Captain Rankin cabled home to the owners for instructions. The authorities here declare that the navy department exceeded its authority in making any promise of immunity from customs regulations.

It is expected that the complication will be straightened out by the navy department adding customs dues to the amount agreed upon in the charter of the Netherlee.
