Little grains of fact sifted from the chaff of gossip flying up and down the town.

Returns to Attend Meeting.—Engineer Sandberg returned to the city on Saturday from Coquille where he is making a perfect map of the city and recent additions. After attending the city council meeting tonight he will return to Coquille to resume work on the tracings of the county records.

Ready for Opening.—The Mill-coma Club will open its handsome new rooms in the Lockhart building tonight with an informal function held for the club members. The formal opening will be held within a few days when the ladies will be present.

Oregonian Is Not Infallible.—The Oregonian of last Thursday, January 2, caused quite a shock to citizens in this city who have been in the habit of staking their all on the infallibility of that newspaper. To be sure it was a common mistake, and its date mark of last Thursday read "December 2."

Fined by Upton.—John Baker was fined \$10 this morning in Judge Upton's court on the charge of disorderly conduct in the opera house last Saturday night. He was charged with sitting unexpectedly in the lap of a lady while under the "influence" in the gallery of the theater, Officer Shoupe making the arrest.

Hunter Leaves For Home.—The tug Hunter left out over the bar Friday for the Umpqua river and Gardiner, after bringing considerable freight to North Bend and loading coal at the bunkers. The big tug is having a busy time of it during the past few weeks, as shipping on the Umpqua has been unusually heavy for this time of the year.

Will Write of Oregon.—"Jack" Gnyton, the local newspaper man representing the Oregonian, has been engaged by a leading eastern magazine to write up various parts of the state, and especially the Coos country. He has contracted to supply a series of articles which will undoubtedly greatly advertise this section of Oregon to great advantage.

Receives New Life Boat.—The tug Roberts left for Florence, on the Siuslaw river, yesterday afternoon with a load of freight for that port in her hold, which is quite roomy for a boat of her description. She also carried a brand new life boat of the most modern unsinkable type, which was brought to this port for her on the Alliance when she made her last trip.

Carter Is Very Ill.—Marshal Carter is still confined to his bed and is a very sick man. He has not been up since Monday morning a week ago but while his conditions is serious, hopes are held out for his early recovery. Quite a number of his friends have made it a point to call upon the marshal, who is decidedly popular in this city, and it is hoped that he will be able to be out again as usual as soon as possible.

Horse and Mail Lost.—Postmaster Curtis has received word that a pack horse, one locked mail pouch and a sack of paper mail were lost at the Brewster grade on the road between Roseburg and Sumner while yesterday's mail was being brought to this city. The horse stumbled in some manner and fell over a cliff into the river with the pack of mail on its back, and it is doubtful if the mail will ever be recovered.

Berwick Preparing to Depart.—The gasoline schooner Berwick, which has been here for several days from Wedderburn, loaded oil at Dow's warehouse today preparatory to taking her departure back to the Rogue River. The boat has four tons of fish eggs in her hold for R. D. Hume, besides a large amount of other freight for Port Orford and Wedderburn. Captain Jacobson and his crew were ashore this morning paying a visit to friends before leaving the harbor.

Boats Being Fixed Up.—The men who make their living by operating launches on the bays and rivers, are beginning to prepare for a large business with the opening of spring. Both the Timmerman and Holland boat building plants have a large number of the small craft on the ways for repairs and improvements. Orders for new boats are also pouring in and appearances at present are that the water front will have more craft than formerly. Pleasure launches are also being fixed up for use.

Greeks Are Leaving.—Nearly every boat from this port is carrying from five to ten Greeks from this locality. Most of them are bound for home, and while the reason is supposed to be the prospects of a conflict between Turkey and Greece, the real reason is said to be that they cannot stand a cut in wages like the native American. Having once secured a good sum as a daily stipend, it is claimed that they will refuse to work for less, and that the result is a number of them in all parts of the country are bound for home with the wages earned during the past few years of their stay in this country.

Prepare for June Election.—Preparations are already being made for the county election next June. On and after today voters may register for the county election and J. T. Hall has secured a large number of blanks which may be had by applying at his office. There will be three precincts in Marshfield in the next election, and the county judge was busy yesterday laying out the dividing lines. Formerly there were two, North and South Marshfield. The extra one will probably compose South Marshfield and Railroad addition.

Fined By Kangaroo Court.—News has leaked out in this city that Manager Nicholson, of the cold storage plant, and Attorney Farrin, were the victims of a "kangaroo court" in Coquille last Thursday night. The victims were pounced upon while eating dinner in the Tupper hotel and taken to a room above the Maryland club for trial. Mr. Becket acted as judge upon this occasion and each victim was fined \$2.50 and costs on the charge of "shooting without a license." The victims had to pay up to the mock court before they would be released, much to the amusement and gratification of the "court."

Stepped on Bud's Foot.—Bud Holland went to the show on Friday night and took chances with a tender foot which has caused him considerable inconvenience. While coming out of the opera house, he asserts that the biggest man present tramped heavily on his foot, causing him some annoyance and pain. At Saturday night's performance he selected a seat near the aisle so as to save a repetition of the tramping act. He says the stoutest woman he had seen in a long while came along shortly afterward and put her whole weight on the tender foot, and he is thinking of securing a cast iron suit in which to see the next performance.

Unable to Attend.—Owing to the recent storms, which have made the roads in a bad condition, Commissioner Carson, of the Third District of Grants Pass, was unable to attend the fruit men's meeting in the chamber of commerce last Friday. He sent a letter regretting his inability to be present, but signified his willingness to be present at the next meeting held. A formal invitation has been sent the commissioner and when he is able to be present, Chairman Coffelt, of the Coos County Fruit Growers' Association will issue a call for a special meeting to hear what Mr. Carson has to say regarding the appointment of a fruit inspector.

Making City Map.—In compliance with the decision made at a recent meeting of the city council, Engineer Sandberg left for Coquille Saturday to make tracings of all the original townsites in the city limits of Marshfield. He will then prepare a comprehensive and correct map of the entire city. For a number of years the city map has been only approximately correct, and as a result of the engineer's work it is expected that the city council will have a perfect map of all parts of the city, including the numerous additions that have been made to the municipality during the past few years. Mr. Sandberg will probably spend a week in Coquille going over the original maps at the county court house.

Newcomers Are Growing.—The number of new arrivals in the city during the past few days has commenced to grow to the proportions attained early in the fall. Every boat is bringing a large number of visitors from all parts of the country, and it is expected that before spring is here there will be a rush to this section which will surpass all previous records. The fame of Coos Bay has commenced to spread in a manner which nothing will stop. What has been started in the way of publicity during the past six months will undoubtedly be felt for years to come, and during that time the city and county will have easily doubled its present population. Most of the new comers are here for investment, while there are a few people among them looking for work.
