ANARCHIST ATTEMPTS KILL CHICAGO CHIEF OF POLICE

Enters Home and Wounds the Chief's Son While Father is Reading Letter.

ANARCHIST IS SHOT AND INSTANTLY KILLED

Gains Entrance Under Ruse and Hands Chief Letter—Three Are Wounded by Would-be Murderer.

CHICAGO, March 2.—George N. Shippey, chief of police of Chicago, today shot and killed an anarchist who invaded his home and wounded the chief, shot his son Harry in the lung and severely wounded the coachman, James Foley. The latter will probably recover. The chief was stabbed in the hand, but the wound is trivial. The assailant entered Shippey's home while the chief and his son were alone in one of the rooms. The man is said to have handed Shippey a letter, which the chief opened and began to read. Immediately the anarchist drew a revolver and fired at Harry. The boy fell to the floor. The father grappled with the assailant. Foley, the coachman, was attracted by the shooting and rushed to his employer's aid. As Foley entered the room the anarchist broke away from the chief's grasp and aimed deliberately at Foley and fired twice. Again the chief closed with the man, the latter turning on him with a knife. Shippey attempted to grasp the weapon and it resulted in a deep cut in the hand. Shippey succeeded in reaching his own revolver and poured shot after shot into the would-be assassin's body, who fell to the floor dead.

Inspiration of Tragedy.

CHICAGO, March 2.—The attack on Chief Shippey is believed to have been inspired by the recent activity of the Chicago police following the killing of Father Leo Heinrichs, of Denver. Following the Denver tragedy attempts to trace the murder of Heinrichs to a conspiracy hatched in Chicago was begun. The local police discovered that a society of Italians that had been formed here had been issuing inflammatory literature aimed at clericals; also that several local clergymen had received threatening letters. Yesterday several Roman Catholic churches were heavily guarded, and all well known anarchists, among them Emma Goldman, were warned that they would not be allowed to make addresses in public.

Assassin Identified.

CHICAGO, March 2.—Detectives have identified the man who attempted to kill Chief Shippey as a member of a group of anarchists who have been holding regular meetings. A friend of the police who attends such meetings to gather evidence identified the body. He told the authorities that the man had been selected to kill Shippey and Mayor Busse.

Will Investigate Anarchists.

CHICAGO, March 2.—There will be a sweeping investigation of the anarchist movement in Chicago by the March grand jury, which was empaneled today.

Will Prohibit Meetings.

CHICAGO, March 2.—It is reported that Mayor Busse is about to issue an order prohibiting all street meetings in Chicago. The order includes religious as well as political gatherings.

ALIO PLEADS NOT GUILTY.

Trial of Priest's Slayer Is Set For March 9.

Residences of Every Style Springing up All Over the City.

These days are witnessing the transforming of thousands of Oregon trees into Coos Bay homes. Every owner of a lot seems possessed with a feverish desire to cover it with a dwelling, consequently cottages, bungalows and the more dignified two-story residences are daily assuming definite shape under the deft handwork of the carpenter. In Marshfield this building activity seems especially marked. Lumbermen and carpenters say the record mark in building will be established this summer, unless something absolutely unforeseen happens. It is impossible to tabulate all the extensive construction and rebuilding, but the brief summary appended will give strangers and others an idea of what is being done in Marshfield.

Mrs. Murphy is building an addition and otherwise fitting up her house in R. R. addition.

B. F. Wyatt will shortly start construction work on a large double house in Plat B, to cost about \$3,000. D. Noah will soon build an 8-room residence on Sheridan street.

Dr. Toye is planning to build a beautiful residence on Nasburg hill. James Baines has the plans and specifications drawn for three modern bungalows to be erected on his property on Sheridan street.

BANDON BOATS MAY LAY UP

Present Marine Crisis in San Francisco Threatens the Nearby Ports.

Current reports in Coos Bay marine circles avouch the threatened tie-up of the steam schooners running into Bandon from San Francisco. Should this occur all the freight shipments consigned to Coquille river ports would have to come via Coos Bay. Unless a sympathetic strike should be called it is said that Coos Bay will not be seriously affected by the present crisis. At present out of the total of 391 coast vessels, over 80 are tied up in San Francisco harbor. Ten of these 101 are owned by independent owners who have announced their intention of running their vessels subject to the marine engineers' rules.

Every vessel is now tied up excepting those belonging to the Caspar Lumber Company, the Cruise Lumber Company, the Eastbrook Lumber Company and the Loop Lumber Company. Over 200 engineers are now estimated to be idle. It is believed the present tie-up will last about two months.

HEADQUARTERS WILL BE IN MARSHFIELD

J. R. Miller Who is Establishing New Boat Line Between Coos Bay

And Bandon Buys Property Here.

J. R. Miller, the proprietor of the new boat Enterprise, which he is about to put on the regular run between Coos Bay and Bandon, Coquille and Port Orford, was a Marshfield visitor this week.

Mr. Miller invested in some real estate adjoining the C. A. Smith mill offices and will also build a home and move his family to this city which will be made general headquarters for the new boat. Mr. Miller met a number of Coos Bay business men and has received many flattering assurances of business for his new line of transportation. The Enterprise will be one of the largest gasoline boats on the bay, being 56 feet long with 13 foot beam and 5 1/2 feet in the hold. A 50-horse power engine will drive its propeller.

OTHER SIDE SCHOOL STORY

A Sumner Citizen Writes in Reference to the Recent Difficulty.

Editor Times: As there lately appeared in the columns of The Times an article which places the Sumner school before the public in a very unenviable and undeserved light, will you kindly allow me space in your columns to correct the erroneous impressions caused by the article in question. A long residence in Sumner and a personal acquaintance with every child in the school has convinced the writer of the fact that no district in the state of Oregon can boast of a more moral, intelligent and obedient lot of pupils than those who compose the Sumner school; a statement which will be confirmed by former teachers who have taught successful terms here, and left, regretted alike by pupils and patrons. It is true that of late our school has been torn by dissension, and rented by discord, a condition of affairs for which outside interference is believed to have been largely responsible, and for which the pupils are in no wise to blame, being merely the hapless victims of circumstances, and deeply do they feel the humiliation of having been placed before your readers in the guise of a lawless mob. As for the alleged assault by 12-year-old Jimmie Stock, the school is practically a unit in declaring that the attack was made upon instead of by him, and that he did nothing worse than seize and hold the stick of stovewood with which he was being belabored. The late teacher having resigned, the position is now filled by Miss Anna Waldvogel, a most estimable young lady of Bandon, who had charge of our school last year, and under whose benign sway no discord marred the session. Warmly Defends Judge Wilfely From Attacks of His Enemies.

BASED ON REVIEW BY SECRETARY ROOT

Defends the Administration of the Court for China at Shanghai—Words Glow With Warmth.

(By Associated Press.)

WASHINGTON, March 2.—President Roosevelt's defense of Judge Lebbens R. Wilfely, based on an analytical review by Secretary Root of the charges made against him, was made public today. They relate to Wilfely's administration of the United States court for China at Shanghai. In a letter to Secretary Root the president says: It is clear that Judge Wilfely has been attacked not because he has done evil, but because he has done good in stamping out vice and crime in Shanghai, and "if the attack were to succeed the beneficiaries would be every keeper of a house of prostitution, every swindling lawyer, and every man who lives by blackmail and corruption in the cities of the far east."
