Brown Defeats Cardwell-Smith And Gage for Sheriff— Bunch for Superintendent.

Returns from the primaries in Coos county yesterday are coming very slowly and were far from complete at 3 o'clock this afternoon. Less than one-half of the 2,807 voters registered participated in the primaries, only about 850 Republican votes being cast and about 300 democrats.

The indications are that Fulton will have a small majority in the county, the vote that Cake polled proving a great surprise to even his friends here. The only way to account for Cake's large vote is that the supporters of Statement No. 1 supported Cake.

Geo. M. Brown ran far ahead of W. W. Cardwell for district attorney. He will have a majority of about 250 in this county and as he carried Douglas county by over 400, he will be an easy victor.

FEAR OTHERS CAUSED CRIME

John Grills' Relatives May Insist on Further Investigation Of Tragedy.

SUSPICIONS ARE AROUSED

Dead Man's Father May Personally Conduct Investigation — Two Victims' Funerals.

A new sensation in the Grills-Roby tragedy was intimated today when Mrs. Wm. Wade, a sister of Grills, announced that the family would insist upon a more thorough investigation of the affair which cost two lives. Mrs. Wade said that they had a number of reasons to believe that others were implicated in the tragedy or at least could tell more about it. "John and Ora left our house not more than fifteen minutes prior to the tragedy and both were in excellent spirits," said Mrs. Wade today. "Ora kissed mother and went out the door joking. John had been angry earlier in the evening because he thought that Ora was paying too much attention to two other young men at the skating rink but they had made up completely and were as happy as could be."

"Ora wore a diamond ring and a plain band ring when she left home Wednesday night. Neither of the rings have been seen since."

Father is Coming.

"I had a wire that our father, John Grills, is sick at Salem or he would be here for the funeral tomorrow. However, he wired that he would come as soon as possible and would insist upon a more complete investigation of the affair, being willing to spend all of the money necessary to ascertain beyond a doubt whether it was murder or suicide or if others were implicated in it. The letter John left is the only real evidence of murder and suicide but there is a possibility that this may be explained."

Dr. E. Mings, county coroner, said that he did not believe that others could have been implicated in it but that he would be willing to aid in any further investigation that was feasible.

Held Funeral Today.

John Grills will be buried at 2 o'clock Sunday afternoon. There will be no services at the church or the residence but the Rev. Father Donnelly will have charge of the services at the grave.

The body of Miss Roby was taken to Salem, via Portland, today by her brother and father. Previous to shipment, funeral services were conducted at the undertaking parlors of T. J. Lewis by the Rev. W. R. F. Browne.

PARIS, April 18.—The Cri de Paris, which professes to chronicle the doings of the fashionable set of Paris insists that the marriage of Madame Anna Gould, formerly the wife of Count Boni de Castellane, and Prince Helie de Sagan, has already taken place and that the ceremony occurred in a little town on the eastern frontier of France and that when in New York Mme Gould informed her family that her wedding was an accomplished fact. It adds:

"This is why her family so quickly assented. We would add that disclosing this marriage can be broken."

CAKE WINS OVER FULTON FOR UNITED STATES SENATOR BY 6,000

FLEET SAILS NORTH TODAY

Battleship Squadron Leaves San Diego for San Pedro Where Brief Stop is Made

(By Associated Press.)

SAN DIEGO, April 18.—The fleet got under way promptly at 6 o'clock this morning. Rear Admiral Thomas personally commanding the maneuvering attending the sailing of the battleships. The fleet will next visit San Pedro, the seaport of Los Angeles, where it will remain until April 25, and thence go north to Santa Barbara, Monterey and Santa Cruz where stops will be made. They will arrive off San Francisco on the night of May 5th, and enter that harbor the following day.

FIGHT FOR GREAT NAVY

Representative Hobson Says That Roosevelt and He Will Continue Contest Indefinitely.

(By Associated Press.)

WASHINGTON, April 18.—"The fight for the big navy will go right on," said Representative Hobson, of Alabama, after an interview with the president. "No battle was ever won or lost on the skirmish lines. We have only just begun, and if John Sharp Williams had not made the matter a party question in the House, there would have been many more democrats voting for four new battleships. The question of the navy is broader than mere party."

WOULD SAVE COOS HEAD

Chamber of Commerce to Petition Secretary of War to Prevent Transfer of it.

The Marshfield Chamber of Commerce will take active steps to prevent private individuals securing part or all of the government reserve at Coos Head. Last evening, the following resolution was adopted by the executive committee preliminary to taking the matter up with the Secretary of War:

"Whereas, It having been brought to the attention of the Marshfield Chamber of Commerce that certain parties are fencing in a portion of the Government Reserve on the South side of the entrance to Coos Bay, commonly known as Charleston Bay, with the intention of obtaining title to the same under the Mineral Laws of the United States; and

"Whereas, The said tract of land has been used by the public as a park and recreation ground for the past fifty years; and its ownership by private parties would work a great hardship on all the people of this community by depriving them of the many natural advantages possessed by the said tract of land, consisting of clam digging, fishing, camping, bathing and many other features not possessed to the same extent by any other place on the waters of Coos Bay.

"Therefore, Be it resolved, That the Honorable Secretary of War be earnestly petitioned to set aside the said tract of land as a public or National Park until such time as it may be needed for fortifications or other special uses of the Government; and that no person or corporation be granted any special privileges thereon."

NORTH BEND TALENT WILL PRESENT PLAY

The Beautiful America Club of North Bend is actively engaged in preparations for the presentation of a play "Capt. Rackett" in that city on Friday evening April 24, to add to its civic improvement fund. The affair is under the direction of Charles Keene and as North Bend is noted for its abundance of amateur theatrical talent there is abundant promise of a flattering success. Rehearsals are now in progress and will continue every night next week.

Present Incumbent Loses By Vote of the Larger Counties.

STATEMENT NO. 1 WINS MAJORITY OF COUNTIES

Only Partial Returns In and Result May Be Changed—Ellis in Lead.

(Special to The Times.)

PORTLAND, Ore., April 18.—Partial returns indicate that H. M. Cake has defeated C. W. Fulton for the republican nomination by from 4,000 to 6,000.

Returns received here show that a majority of the nominees for the legislature are Statement No. 1 men.

Advices to the Evening Telegram indicate that Fulton carried Lane, Morrow, Sherman (very close), Crook (very close), Josephine heavy), Marion, Clakamas, Douglas, Tillamook, Coos, Polk and Grant.

Cake carried, Multnomah (very close), Marion, Clakamas, Douglas, Linn, Jackson, Wasco, Yamhill, Union, Umatilla, Baker, Columbia and perhaps Washington.

Cake's majority will probably be over 6,000.

DETAILS OF VOTE.

(By Associated Press.)

PORTLAND, April 18.—The returns from the various sections of the state indicate that Oregon's primary elections, yesterday, resulted in the selection of H. M. Cake over Senator C. W. Fulton for the republican nomination for U. S. Senator, and that S. R. Ellis in the second congressional district has defeated former Governor T. T. Geer, and George S. Shepherd.

There seems to be no question that Statement No. 1 candidates carried a majority on the legislative ticket.

However no news can be obtained from a number of isolated counties and when the returns from these counties are in, the face of the situation, so far as Statement No. 1 is concerned, may be changed.

In the first congressional district, W. C. Hawley had no contest.

Robert S. Bean is nominated for justice of the supreme court.

In Multnomah county, Cake is about 2500 ahead of Fulton and Shepherd is about 1,500 ahead of Ellis.

The returns from outside counties are greatly in Ellis' favor and he is expected to win out by about 2,000 votes.

RESULTS IN DOUGLAS COUNTY.

(Special to The Times.)

ROSEBURG, Ore., April 18.—Returns received from thirty out of the thirty-one precincts in this county gives Cake a vote of 92 and Fulton 784. Brown for district attorney, 1069, and Cardwell 699; Abraham wins for State Senator by a majority of 25 votes, an ardent supporter Statement No. 1.

Appleby and Jones win for Representative, the former being an anti-Statement No. 1 candidate, while the latter is a signer of the measure. Vote comparatively light. Sherwood receives nomination for District Attorney on Democratic ticket.
