INJURED ON BREAKWATER: WANTS \$25,000 DAMAGES

Ernest Stenzel, Former Carpenter on Steamship Begins Suit For Large Sum at Portland.
PORTLAND, Ore., Aug. 28.—Suit for \$25,000 for personal damages has been instituted against the Southern Pacific Company in the United States Court by Ernest Stenzel. In his complaint Stenzel, who is represented by Henry E. McGinn, charges that while attempting to board the steamer Breakwater, owned by the defendant company, on the night of December 14, 1907, he walked off the defective approach to the boat and sustained injuries by reason of which he has been injured permanently. Stenzel alleges in his complaint that he was employed as carpenter on the defendant company's boat, and the injuries sustained are alleged to have resulted from the fact that the approach to the boat was not protected and lighted as required by law.
