Small Potato Crop.—The potato crop of Coos county will not be as large as it was last year but they will be of better quality. Large growers in the Coquille valley report that the crop will be only about one-half as compared with last year.

May Play Ball.—There is some talk among the fans of getting up a good amateur ball team and arrange for a series of games between Coquille and Marshfield. Both cities have good material to form a good team and a purely home team has always been liberally patronized by both sides.

Lumbermen Visit Here.—G. B. McLeod and F. R. FINDS BOGUS MONEY HERE.
Government Authorities Look Up Spurious Coin.
An inspector of the internal revenue department has been in Coos county for several weeks looking into alleged irregularities by several persons in the liquor business. While in Myrtle Point he made a collection of counterfeit money, mostly silver 25 and 50 cents pieces, which he took to Portland to turn over to the federal authorities. There has been considerable complaint about bogus money in Myrtle Point for some time and it is believed that there is a plant located near that place or around the Bay.

TEACHER IS DEAD.
Miss Mildred Brown Succumbs In Camas Valley.
Miss Mildred Brown, aged 27, died at the home of her parents, Mr. and Mrs. M. L. Brown at Camas Valley, on Friday night, September 4th, from an abscess. The funeral was held at 1 o'clock Saturday afternoon, Rev. Mr. Hampton officiating, and interment was in the upper cemetery. Besides the parents, five brothers and two sisters survive. Two of the brothers are L. E. and Arthur Brown, the Myrtle Point merchants, one lives at McKinley, one at Camas Valley and one is a non-commissioned officer on the cruiser Marblehead, now in the Alutian group of islands; two sisters, one of whom is married, live at Camas valley. Miss Brown was born in Kansas, removed with her family from Nebraska to Camas valley in 1900, and has taught school in that section.—Myrtle Point Enterprise.
