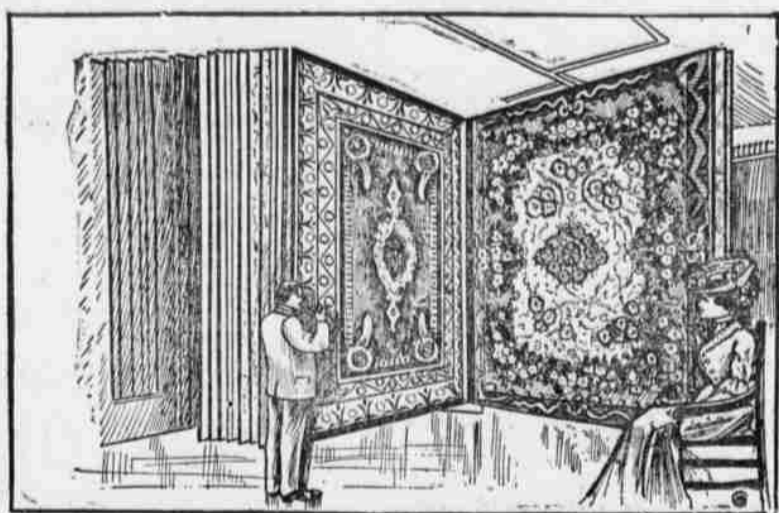

Council to Meet.—The Marshfield city council will meet tonight to take up street improvement matters and also to pass on the resolution introduced last week providing for an increase in the maximum indebtedness of the city. The latter will have to be done by amending the charter and floating a bond issue.

Mr. Cox says that the report from Coquille that his father's death was hastened by worry over the outcome of the damage suit in which he was involved was incorrect, his parent dying six hours before the verdict was returned. Mr. Cox says his father had been ill for some time and that for several weeks it was known that the illness would soon terminate fatally. In the lawsuit, Mr. Cox received a verdict for only \$1,000 for the injuries he sustained in the wreck on the local railway several months ago and friends who are familiar with the case believe he was entitled to more.

Events of Interest As Told By the Wedderburn Radium.

Mr. and Mrs. David Wright have gone to Coos Bay to purchase household goods and attend to other business matters. They will be absent about two weeks.

The fishing season opened last Wednesday in Wedderburn and fourteen men drew the large seine. The haul netted 207 fish, mostly fine, large chinook, while there were perhaps twenty silversides and a very few steelheads.

A. M. Barcus took up his duties as manager of the cannery and foreman of outside work last Saturday. He comes to Wedderburn from North Bend, where he had been engaged with a sawmill company for a year past. He has been a resident of Oregon but a year, having come from the Atlantic states.
