

# HONORS ARE SPLIT EVEN

**Marshfield Boys Defeat North Bend Basketball Five—Visiting Girls Win.**

Marshfield boys winners by a score of 13 to 10 and North Bend girls the victors by a score of 18 to 2 in the way two games of basketball resulted last evening at the skating rink, the two former teams on the floor being the Marshfield High School five and the North Bend Miller-Cleaver Business College five, and the two latter being the North Bend High School girls and the Marshfield High School team.

The game between the two young men's teams was a particularly brilliant exhibition and from start to finish the result was in doubt. Excellent individual playing was a feature of the contest and at the conclusion of the first half, the visiting team led by a score of 7 to 5, Stanley Briggs and H. Briggs of the locals, each scoring a goal and the latter a foul. In this half Curtis for North Bend scored one goal, Shook two, and Bright a foul.

## Win in Second Half.

In the second half, the Briggs boys again demonstrated their ability, Stanley Briggs and Rasmussen scoring the goals and H. Briggs four fouls. For North Bend in this half Curtis scored another goal and Bright another foul.

In the game between the two girls' teams Belva Flanagan scored two fouls, the only points made by the Marshfield team. Lucille Greenleaf, for North Bend, scored four goals and two fouls and Ellen Anderson and Edith Alger two goals each.

Although the weather was extremely disagreeable the rink was crowded and the local teams profited to the extent of about \$17 as a result. This money will be used to defray a portion of the expense of the field meet of the county high schools to be held in May.

The jury declared there was water in the boiler and no indications of overheating.

## ELECTION ONE-SIDED.

**Myrtle Point Voters Declare for Better Waterworks System.**  
The Myrtle Point Enterprise says: "The results of the special city election held last Monday showed plainly that it was a one-sided matter and that there was a consequent lack of interest. But eighty-seven votes were cast, of which 77 were in favor of the proposed amendment and but seven in opposition. Three ballots were thrown out by the board, but there is no possibility that the election will be contested, as the votes counted were 11 to 1 in favor of amending the charter."

"The proposition voted on was the amendment of the city charter permitting the raising of the limit of indebtedness for waterworks purposes from \$25,000 to \$50,000, the object

being to permit the expense necessary to replace the present wooden mains with steel or iron piping. "The next step in the matter will be a vote to issue the bonds required to meet the expense of the proposed change. The \$24,000 limit will un-

doubtedly be passed in making this change.

# OPPOSED TO THIRD JUDGE

**Citizens League Declare Against Plan But Favors J. F. Hall For Place.**

The Marshfield Citizens League at a meeting last night declared itself opposed to the appointment of a third judge for this district of the circuit, claiming the business was not sufficient to warrant the expense of a third man on the bench. However, as the matter had been taken up with the legislature with a probability that a third judge would be ordered appointed for the district, the Citizens League declared itself in favor of the appointment of Judge John F. Hall of Marshfield.

The proposed bond issue by the city to take up the special improvement bonds was also discussed at length. Many expressed themselves opposed to the plan, declaring the city's bond issue would have to run for at least ten years while the special improvement bonds might be taken up at any time, thus making a possibility of the city paying interest on a bond issue when the money derived from them would not be in use.

J. N. Nelson proposed a script issue to take care of public improvements. It was a new idea to most of the members and no action was taken on it.

There were not many present last evening and it was decided in future all of the members should be notified shortly before the meetings.
