RETURNING PROSPERITY.

THAT THE PIPING times of national business prosperity will soon be as good as they ever were, if not better, is indicated by dispatches from Pittsburg. Reports compiled at general headquarters in that city show that the number of surplus freight cars in the Pittsburg district has been reduced two-thirds since January 1. Coal operators are worrying about the lake seaman's strike, which is said to be delaying shipments to the northwest, and already there are predictions of car shortages and congestion, notwithstanding that many of the big lake boats are already shutting back and forth, some with non-union crews and others manned by union sailors to whose terms the vessel owners have agreed.

In anticipation of greatly increased rail business orders for new freight and passenger locomotives placed during the last ten days exceed those of any two months in the last two years. The Harriman lines alone are receiving bids for 145 engines. May be they will use one of them on the Drain-Coos Bay run.

AIRSHIPS AND THE TARIFF.

IN DRAFTING amendments to the Payne tariff bill, the United States Senate has not taken into account the effect which Major Baden-Powell declares the operation of airships will have on international tariff. The major, discussing aerial navigation in the National Review, declares that flying will become common means of transportation within four years, and that such problems as the rules of the air, recognition of international frontiers, the ownership of the air above, and the establishment of a flying squadron of police must be solved soon.

Smuggling, it is declared, is likely to become easy and lucrative and the restriction against alien immigration of no effect on account of the insurmountable difficulty of halting airships at frontiers. Because of the danger which Major Baden-Powell believes is imminent, it is facetiously suggested that congress abolish duties on all commodities except grain, coal and lumber and a few other bulky articles of commerce. Else some dark night an airship load of smuggled diamonds from Africa, Teddy bears from Germany, knives from Sheffield and brushes from Japan might be landed on Coos Bay and Major Tower would never be the wiser.

MAKING ADVERTISING OF PUBLIC VALUE

Occasionally a business man is found who will say in all seriousness that he advertises to help the home paper along, or because he does not want to be considered less enterprising than his competitors. Such advertising is entirely wrong in principle, and it is doubtful if the paper that accepts it is permanently profited thereby.

There was a time, not many years ago, when advertising was not looked upon as a business asset and investment, and this thought is still reflected in the so-called advertising of a decreasing number of business firms who advertise screen doors in January and snow shovels in July.

Fortunately for the commercial interests of the country, these alleged business men are becoming so scarce that their very novelty attracts attention, and they are being largely superseded by the dealer who considers his advertising one of the

most necessary and important features of his business.

With the modern merchant it is no longer a matter of advertising to help the newspaper, but how much the newspaper can help the trade of the dealer by publishing his announcement in attractive form and securing their entrance into the most desirable homes from a business point of view.

Quite a number of influences have brought about the change from the old to the new, and chief among them is the demand of the public, especially the female portion of it, for real business news—news that is read with as much avidity, and frequently with more profit, than any other section of the paper.

The dealer who refuses to accede to this insistent demand for news of his goods and business methods is rapidly giving place to the merchant who takes the public into his confidence and doesn't hesitate to cater to the bargain instinct; for he knows that real values are appreciated by the purchasing public and will make him friends.

The time was when the average reader rebelled at the quantity of advertising in his newspaper; now he realizes that it is one of the most valuable features to himself and family, and he is quick to profit by the offers made by the enterprising dealers of his city.—J. Harry Reed, in Printers' Ink
