## CLOSE OF CONGRESS

which I am told is the easiest passage over the mountains."

Mr. Hawley closed his remarks with a glowing account of what he believed he would live to see on Coos Bay. He said it would be one of the greatest manufacturing centers. That the city would be spread over the entire territory around the bay and that all of the water front of the bay and inlets would be crowded with boats waiting to take away the products of its factories.

#### As to the Dredge.

An invitation was given to any who wished to ask Mr. Hawley any questions. Peter Loggie of North Bend, said that he had enjoyed the speech but he wanted to know why the government dredge had been ordered to leave here within a month and what Mr. Hawley was doing to have it remain here. He said that the dredge idea emanated from Coos Bay and that promises had been made that it should remain here as long as it was needed.

Mr. Hawley said that the bill providing for the dredge was passed before he entered congress so he could not be held responsible for the law itself. In his original address he said that he wanted to see the dredge stay on Coos Bay as long as it could be of any good and repeated that such was his position. He said the dredge was still here but that he had heard something about its being ordered away and that he was co-operating with the local people to do all he could to keep it here as long as there was any chance of dredging any of the bay or filling in any of the low places around the bay.

#### R. G. Smith Speaks.

R. G. Smith of Grants Pass, was another interesting speaker. He told of the difficulties of the overland routes to Coos Bay and the necessity of a railroad. He said the Legislature was not always to blame for preventing railroad building as the roads had for a great while had their own way in the matter of charges. "A community," he said, "generally got what it deserves and if Coos Bay never gets a road it would likely be due to the fact that the community had not deserved it. The question is," Mr. Smith said, "whether Southern Oregon would wait until someone came along and built or whether they would get one themselves by proper encouragement. Coos Bay was pictured as being surrounded on one side by the Pacific ocean and on the other side by E. H. Harriman."

Mr. Smith placed himself on record as being against allowing any railroad to tie up a community. He said that if a road was built from Coos Bay to Roseburg it would be bound to go on up the Umpqua river and across Oregon, and would be a part of a transcontinental railroad which would give the locality great influence in securing government help for the harbor. "Mr. Smith approved of the present move of Coos Bay people to survey for a road of their own and thought there would be no difficulty in getting the money to put it through. He also thought that any county in the state would join in a move. Mr. Smith suggested that if a district was to be made for building a railroad, the people should protect themselves with proper laws. The great wealth of timber and other resources of the country was referred to and he thought there could not be a better inducement for capital than to build a railroad to Roseburg and if a corporation would not build, a public body could and would be able to sell it later on to a corporation. Mr. Smith said if the Coos Bay people would build a railroad he would promise to come down and live here.

Following, Mr. Smith's address, there was music by the orchestra before the next speaker was introduced.

#### Bandon Invitation.

Chairman Hofer announced that the city of Bandon had sent a delegation to the Congress although the city had just suffered the loss of a \$100,000 fire but in spite of this

fact the people had raised \$500 to entertain the visitors at a clam bake Sunday. Col. R. H. Rosa was introduced and personally asked the delegates to come to Bandon Sunday and enjoy the entertainment and inspect what had been done by that city in the way of starting a railroad into Curry county.

#### Talks On Good Roads.

Judge G. W. Dimmick of Clackamas county, was introduced as a man from a county which has been foremost in good road building. Chairman Hofer said that Coos county needed good roads and what he would have to say ought to be of help. Judge Dimmick made a brief address encouraging what had been done in this county and urging the people to advance along the lines of good road building. His address concluded the night session.

#### Urge Hofer to Serve.

The business session of the Congress for the delegates only was held at the Chamber of Commerce rooms this morning. Dr. J. T. McCormac presided. William Grimes made a speech in which he stated that all the enthusiasm which had been aroused and all the work that had been accomplished by the Congress was due almost entirely to one man, Col. E. Hofer, the president, who had been untiring in his efforts to make the Congress a success. Mr. Grimes said that the Congress must have Col. Hofer again for president and Rellly Atkinson of Boise for secretary.

Col. Hofer said that he would have to consider whether he could afford to take the office again. He said he had spent a great deal of time and money while holding the office. It was explained that the officers all had paid their own expenses.

H. C. Diers of North Bend, said that there were plenty of people around Coos Bay and around Boise and that if each one of them would give one dollar there would not be any trouble about having enough money to keep up the Congress without the officers being put to any expense.

Col. C. E. S. Wood of Portland, spoke. He said that it was due to the work of Col. Hofer that the Congress had been kept together and that it was his work which had stirred up all the railroad prospects.

Secretary Atkinson was not able to be here on account of the illness of his wife, so it is not known whether he will accept re-election. The matter was left awaiting the decision of those two officers as to whether or not they would take the offices for another term.

Resolutions will be prepared and will be presented to the Congress

for passage at the meeting this afternoon or tonight.

#### Visit Smith Mill.

All of the delegates were taken during the forenoon to the C. A. Smith mill where an inspection of the entire plant was made. The company showed the visitors everything there was to see about the big mill and the visit was a revelation to many of the strangers.

#### NOTES OF CONGRESS.

C. H. Jones, a representative of the Statesman of Salem, is in the city to report the Congress.

The steamer Liberty took a large number from North Bend, Tom Hall being the captain and Jas. Rolandson the engineer.

The Chamber of Commerce was handsomely decorated by the the A. N. W. Club ladies. There is a profusion of flowers that has excited the admiration of the throngs that visited the quarters.

Col. Rosa, Steve Henderson and other Bandon delegates have been busy for the past twenty-four hours pinning Bandon badges on the delegates and others and working up enthusiasm over the excursion to Bandon Sunday.

Congressman Hawley, C. S. Jackson of the Journal, John Carroll of the Telegram, and George M. Cornwall of The Timberman, were among the guests who went with Dr. and Mrs. J. T. McCormac on the Dixie to the lower Bay yesterday.

Of all the busy people that Coos Bay has seen in many a day, Col. Wm. Grimes and Miss Violet Henderson were the busiest. The bulk of the detail work of the preparations for the Congress has fallen on Col. Grimes and his chief assistant has been Miss Henderson. The success of the event was largely due to Mr. Grimes' personal efforts.

Charlie Lindsey, the irrepressible and irresistible representative of W. P. Fuller & Co., was on deck as the original Coos Bay booster. He was accompanied by W. L. Whelan assistant general manager of the company for the Pacific coast. Mr. Whelan was very favorably impressed with this section and after meeting some of Charlie's friends, said he didn't blame Charlie for trying to have the company assign him to regular duty on Coos Bay.

W. B. Glafke, president of the Portland Chamber of Commerce and representing that body as well as the Portland Commercial Club, is greatly pleased with Coos Bay. He says that Portland business men are more than friendly to Coos Bay and willing to help this section. He declares that Coos Bay can rely on the assistance of the Portland Commer-

cial bodies any time it asks it. Mr. Glafke is one of the leading business men of Portland, M. D. Poyntz, representing his firm in this territory. O. O. Lund has one of the most interesting windows in the city at 315 Broadway, containing mounted specimens of Coos county game. Strangers should see it.

Judge Grant B. Dimmick, who has attained a state wide reputation as a good roads builder and an advocate of good roads, is here from Clackamas county for the convention and delivered an able address last evening on good roads. Mr. Dimmick is prominently mentioned as a candidate for governor and will likely enter the race.

Said George Cornwall, publisher of The Timberman of Portland: "If Coos Bay people think that Portland is against them in any way they are greatly mistaken. We, people in Portland, would like to see Coos Bay go right ahead and will help in every possible way we can. If we could give you a railroad we would do it and feel that we would profit by your growth."

L. R. Alderman of Eugene, a well-known Oregon educator who has been assisting in the Coos county institute work at Coquille, is here to attend the congress. He is talked of as a candidate for state superintendent to succeed Superintendent Ackerman. Prof. Ressler of the Oregon State Agricultural College, who was here this week is also a prospective candidate. Superintendent R. F. Robinson of Multnomah county public schools, another instructor at the institute, is also here. He is also talked of as a candidate for state superintendent.

#### Ackerman Here.

State Superintendent J. H. Ackerman came over Friday from Coquille where he has been attending the Coos County Teachers Institute. It is a well-known fact that Mr. Ackerman will be a candidate for governor next time but owing to his holding a public office now, he has decided not to make an official announcement of his candidacy until shortly before the primaries. He is a firm believer in Coos Bay and a booster for its development as well as the rest of the state. At Coquille yesterday, he heartily indorsed the plan of Judge Sheibred to have a summer training school for teachers started here. The Coos county directors indorsed the plan and Superintendent Bunch will name a committee to punch for it.
