Will Celebrate.—The Marshfield Fire Department has decided to hold a big Fourth of July celebration in Marshfield this year and will immediately begin preparations for it. It is planned to have a county firemen's tournament at the same time and have several of the towns unite in the event.

Leave Tomorrow.—Ray Young and Chas. Duggan, whose fathers were lost with the Czarina, will leave for their home in Frisco tomorrow, going via the Breakwater to Portland. Harry H. Kentzell, the sole survivor will also return home to Frisco tomorrow via that route. D. W. Paul of the Sailor's Union, will return to Portland.

Is Olson.—Mate Wall of the Breakwater, formerly with the Czarina, today identified the body of the first victim of the Czarina that was washed ashore as that of M. Olson, a sailor. This confirms the identification of the longshoremen and is directly opposite to Harry Kentzell, the only survivor, who maintained it wasn't Olson but was that of the cook. No more bodies have been washed ashore from the wreck.

EVIDENCE IN HERMANN CASE

George Sorenson Testifies Against Former Congressman Today.

(By Associated Press.)

PORTLAND, Jan. 20.—"Former Congressman and commissioner of the general land office, Binger Hermann, and late United States Senator, John H. Mitchell, were "The people at Washington" who were working in the national capital to create the Blue Mountain forest reserve," said Franklin Pierce Mays, according to George Sorenson on the witness stand at the Hermann trial. This was the first time the mysterious "people at Washington" were identified by name and the defense immediately interposed an objection. Judge Wolverton held that this declaration should be disregarded by the jury unless there is further evidence connecting Hermann with the conspiracy. Sorenson's testimony created little comment among the spectators. Incidentally it was disclosed by the testimony of Sorenson that the Oregon state land board during the administration of former governor T. T. Geer was aware of the swindles being carried on in school lands.

WRANGLE ALL DAY.

Attorneys in Hermann Case Clash Over Letters.

(By Associated Press.)

PORTLAND, Jan. 21.—Attorneys in the trial of Binger Hermann wrangled all day today over the admission of certain letters written to Hermann while he was commissioner of the General Land Office and in which he was apprised of schemes of land grabbers in this state. The defense objected to the introduction as the letters had already been introduced in two trials of Hermann at Washington and the trials of Hyde and Benson. The arguments continue this afternoon.

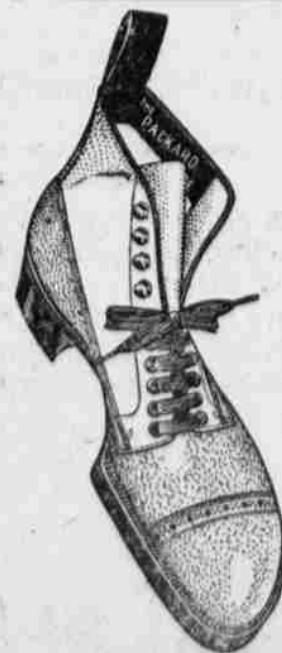
