MISSOURI'S JOSEPHINE deserves a niche in the herbivorous hall of fame. Knowing the skeptical type of mind for which her State is famous, she set out some time ago to give an actual demonstration of what could be done in the milking line by a really competent cow.

For six months the milk poured out of her like a waterfall; at the end of the test her record stood at 16,744 pounds. That is, for 180 days she "gave down" at the rate of a fraction over ninety-three pounds a day, which appears to be the equivalent of about forty-five quarts. At local prices her daily output in dollars and cents was thus something over \$4, or at the rate of \$1,460 a year, including Sundays.

We commend Josephine to the attention of the Coos county farmers and milk dealers. If they would make an effort to instill a little of her ambition and perseverance into the Coos county herds our development problem would be greatly simplified. If Josephine could do it, other cows can. Giving milk isn't a matter of genius; it depends upon training, breeding and feeding. The Coos county farmer has just as much control of these conditions as his Missouri compatriot.
