## French Newspaper Makes Comment Upon the Spanish Crisis,

(By Associated Press.)

PARIS, August 12 .- Les Nouvelles to-day says that it is authorized to deny the statement by the Madrid Epocha that Premier Brian had advised King Alphonzo against the rupture with Rome. The paper further says the King told Brian that he did not propose to obey the injunctions of the Vatican, to tolerate the threats of the Vatican or to allow the Vatican to mix in Spanish politics. Les Novelles says that Brian did offer sage advise to the young monarch, warning His Majesty to proceed diplomatically and to avoid brusqueness.
