REGISTHATION FIGURES FOR LIVELY TIMES COOS COUNTY ARE COMPILED

The registration in Coos county this year is a heavy one. According to the figures furnished by the Count y Clerk and indicated in the tabulated abstract there is a total of 3,316 voters registered before the primarles. Last year before the election there were 3939 registered. When the books go back into the hands of those who are registering this difference will be more than made up and the total registration before the election this year will be greater than last year.

Populists are rather scarce. There are only three registered in the county. There are only 31 prohibitionists. The following table shows the number of voters registering in the different precincts:
