ARMED BRITISH FORCE IS LANDED AT MEXICAN PORT

Marines With Maxim Gun Sent Ashore at San Quentin to Oppose Rebels.

INSURGENT ATTACK FAILS TO MATERIALIZE

Troops Are WithDrawn Without Bloodshed—News to London Not Official.

SAN DIEGO, Cal., April 15.—"A big fuss over nothing," said Capt. Vivian of the British Sloop of War Spearwater today when shown the despatch from London stating that he had made no report to the British Foreign Office regarding the telegraphic advices that he had landed a party of marines and Maxim gun at San Quentin in Mexican territory April 11. He stated the affair was too insignificant to warrant cabling but had forwarded written reports to London and to the Embassy at Mexico City. He stated he landed the marines to protect lives and property of British and American subjects. He stated that upon the appearance of the so-called revolutionists at the town, the Mexican officials left the place at the request of British and American business men he landed a force of five o'clock Tuesday afternoon. The marines remained ashore until ten o'clock the next morning, and there was no appearance of disorder were withdrawn at that time and the vessels left port Wednesday.

NEWS TO LONDON. British Officials Not Apprised of Incident in Old Mexico. LONDON, England, April 15.—Cables here from Washington state a force of marines with a Maxim gun from the British Warship Spearwater were landed last Tuesday at San Quentin, in lower California, to meet that town against an attack the Mexican insurgents came as a complete surprise to the British Foreign Office. Nothing whatever has been heard of the incident though the commander of the Spearwater reported his arrival at that port.

RUSH MORE TROOPS TO BORDER MEXICAN FEDERALS AND REBELS RACING FOR JUAREZ TODAY

Four Additional Troops of Cavalry Ordered to Arizona to Guard Mexican Border.

(By Associated Press to Coos Bay Times.) WASHINGTON, D. C., April 15.—Following a conference at the White House today between Taft, Secretary of War Dickinson and General Wood, the latter announced that four more troops of cavalry would be ordered to Douglas, Ariz., to assist the United States troops there.

At the White House it was announced today that assurances had been received from the leader of the insurgents at Agua Prieta by the Department of Justice that the incidents of Thursday which resulted in the killing of several Americans and the wounding of others will not be repeated. According to the announcement of Attorney General Wickham communicated with the United States District Attorney at Douglas, Ariz., and directed him to inform the rebel commander that in the future he must keep away from the American borders. Wickham was informed later that his instructions had been carried out and that the insurgent leader was anxious to obey.

TO MAKE GIFTS PUBLIC EARLY

House Will Pass Campaign Publicity Measure—Iowa Scores Morgan. (By Associated Press to Coos Bay Times.) WASHINGTON, D. C., April 15.—The House adopted an amendment to the campaign publicity bill offered by Jackson of Kansas to require all candidates for congress to make public all contributions by them and the manner in which the money was expended. The vote was 172 to 131, all republicans voting for it. The Rucker bill providing for additional publicity of campaign contributions will be passed with many republican representatives voting in its favor. With the publicity bill out of the way, the House will proceed to consideration of Canadian reciprocity.

WILL EXCLUDE ALL ASIATICS

Chinese Exclusion Law to Be Made to Apply to All Easterners. (By Associated Press to Coos Bay Times.) WASHINGTON, D. C., April 15.—An immigration bill affecting all Mongolian peoples was introduced today by Representative Hays of California. The bill provides that all laws now in force prohibiting or regulating the incoming of Chinese or persons of Chinese descent into the United States be made to apply to Japanese, Koreans, Tartars, Malays, Afghans, East Indians, Lascars, Hindus and all persons of Mongolian or Asiatic race or extraction. It is further provided that all persons affected by the proposed law who now in the United States other than those engaged as teachers, students, merchants, bankers, or professional men or persons touring the country for pleasure must within a year after the passage of the act apply to the Secretary of Commerce for a certificate of residence. All such persons who have not certificates of residence will be arrested and will be subject to deportation. The bill was referred to the Committee on Foreign Affairs.

SCHOOL WORK IS DISCUSSED

Opposition to Abolition of Departments Expressed at Chamber of Commerce. The question of whether or not the Marshfield school board was acting wisely in abolishing the domestic science, drawing and music and commercial departments of the Marshfield high school was brought up at a meeting of the Chamber of Commerce last evening. A. H. Powers brought it up and declared that he personally was opposed to "gigging back" on these departments as he believed they were highly beneficial to the young folks of Marshfield. He said he believed it would be a big mistake to stop these departments now for a slight saving. Dr. McCormac of the school board who was present said the board wanted to get expressions from the patrons of the school along these lines. He said that the Commercial department had been started for the purpose of avoiding the necessity of sending young folks away to get instruction in these departments but somehow or other appreciation was not shown of it and less than a dozen pupils were now availing themselves of the opportunity for the special instruction. He said the school board wanted to hear from the patrons of the schools about the matter.

DRAIN ROUTE IS ADHERED TO

Southern Pacific Officials Declared to Have Given Up Eugene Project. According to unofficial but well substantiated advices that have reached Coos Bay, the Southern Pacific officials have decided that the extension to Coos Bay shall be built via Drain instead of via Eugene and Florence as was urged by General Manager O'Brien of Portland. The decision is said to have been reached a few days ago, the Drain route which was the choice of Vice-president Calvin at San Francisco being adhered to by the eastern officials of the road after examining the claims set forth for both routes. However, the date of building the line has not been fixed or at any rate not announced. Some of the Southern Pacific officials say that work on it may be resumed this year but that it is not certain. The old surveys and plans will be adhered to. However, it is not anticipated that any announcements will be made regarding the matter until certain properties which the company desires are secured.
