A REVIVAL IN LUMBER MART

President of Milwaukee Road Says Big Crops Will Bring Orders.

SEATTLE, Wash., June 19.—A. J. Earling, president of the Chicago, Milwaukee & St. Paul Railway, accompanied by a number of Eastern business men, arrived from Chicago Saturday on a tour of inspection over the Milwaukee's lines.

"The yield in the Dakotas, Iowa and Minnesota," he remarked, "will be the largest in their history." As a consequence there will be a heavy demand for lumber and other forest products of the Puget Sound country.

BOSTON IS NOT COMING HERE

Training Ship Boston Ordered to Portland—Naval Reserves Homeward Bound.

Coos Bay residents are somewhat disappointed at the news received on the Bay recently that the Training Ship Boston will not come here direct from the Bremerton Navy Yard, but will proceed first to Portland, where the ship will remain an indefinite length of time.

From present accounts, Portland has persuaded the authorities to permit the Boston to remain there for an indefinite length of time.

It is reported that an agreement has been reached, and which is concurred in by the government that Portland and Coos Bay are to have the Boston for periods of six months at a time.

OBITUARY

In W. D. Williams, who died in Empire City, on the 12th inst., was embodied the nearly perfect man.

Of exemplary habits, the result of early home training, it can be truly said of him that the familiar lines in Holy writ:

"I have fought the good fight, I have finished my course, I have kept the faith," would form a fitting epitaph.

Born in Carmarthenshire, South Wales, May 19, 1847, Mr. Williams had not reached the close of the first month following his 64th birthday.

An apprentice in the "Star of Wales" printing establishment, in Carmarthenshire, Mr. Williams learned book-binding, and making, purposing to pursue the calling in after life.

Accompanied by his wife, who survives him, the deceased came to the United States in 1871, and was for many years located in Pittsburg, Pa., or properly speaking "Soho," engaged as a coppersmith and while in this pursuit was stricken with partial blindness, and consequent ill-health, to regain which with his family he re-visited the home of his youth, and Australia, in due course returning to the United States, and later to this coast, locating for some time in San Francisco, whence in 1908, having become totally blind, at the solicitation of his daughter, Mrs. R. H. Olsen, with the devoted wife he established himself in Empire City, well known to many Coos Bay people as the nephew of the late, much respected B. D. Jones.

It can be truly said of Mr. Williams that for more than two years he was not without much pain, suffering with rheumatism followed with Bright's disease, and heart trouble, of which he died, yet at all times was he cheerful, sustained by the promise that there was "a mansion prepared, literally the text of the Reverend G. Reroy Hall, who in officiating at the obsequies cited us to: St. John 10th Chapter, 9th Verse:

"I am the door; By me if any man enter in, he shall be saved."

The allegory fully sustained in the character and walk of our late neighbor, father, and friend, has robbed death of its sting, even as it has the grave of victory.

It is for us, the living, to emulate this character, and in doing so we do better honor his memory.

OPEN NEW ROAD TO COQUILLE

New Road by Shingle House Inlet Will Shorten Distance Over a Mile.

Travel between Marshfield and Coquille will be greatly facilitated by the completion of the county road within a short time. Judge Hall of the County Court while in sitting at Coquille, authorized the supervisors of districts 5 and 9, in which respective districts the road is located, to go ahead, and lay down several hundred feet of plank road in the vicinity of shinglehouse inlet, thereby connecting the two roads. The work it is estimated will cost in the neighborhood of \$2,000 and will be paid out of the county funds.

The distance saved in traveling from here to Coquille by the new road will be a little over a mile, but the greatest advantage to come from the shorter route will be the avoidance of the steep grades which are many on the old road. The new road is three miles in length. Nearly two and a half miles of the route is parallel to the railroad. It is level all the way with the exception of a few small grades.

ALONG THE WATERFRONT.

The steamer Alliance will arrive tomorrow from Portland.

The steamer President arrived today from Coquille and river points.

The San Pedro arrived in Coos Bay this morning. The San Pedro will take on a cargo of lumber at the C. A. Smith Mill for San Francisco.

The steamer Redondo, which left San Francisco yesterday afternoon is due in Coos Bay tomorrow morning. The Redondo will start on her return trip to San Francisco on Thursday.

According to advices from Portland Captain "Billy" Patterson is a favorite in the race for the office of inspector in the Seventeenth Lighthouse district which will be vacated July 1 when Commander Elliott who arrived in port on the L. H. E. tender Manzanita after an inspection tour, will return to the navy as a captain in command of a vessel. Superintendent Warwick of the lighthouse service, and his chief deputy are also contenders.—Astorian.
