NET IS TIGHTENING AROUND BANDITS WHO ROBBED MAIL CAR

Identity of Men Who Held Up Train at Drain Is Discovered.

SHERIFF GAGE AND DEPUTY JOIN IN CHASE

Indications Are That Posses Will Have Them Surrounded Tonight.

ROSEBURG, Ore., June 21.—Detectives believe they have discovered the identity of the thieves who held up the Shasta Limited and robbed the registered mail pouches last Friday night. Two ranchers who live in the mountains near Yoncalla have been missing since last Friday. The search of their premises shows, guns and ammunitions known to be in their possession are missing. The men whose names cannot be divulged under the circumstances are experienced mountain men and know every foot of the country in the vicinity of Loon Lake, where they are now supposed to be in hiding.

The Net Is Tightening.

DRAIN, Oregon, June 21.—Indications are today that the posse which has been pursuing the two masked men who robbed the mail car of the Shasta Limited last Friday night, are getting close upon their quarry. The blood hounds have taken the posse into the Loon Lake country over towards the coast in the direction of the mouth of the Umpqua river and the sheriff believes the men may be captured before tonight. From the desperate flight which the men made generally it is thought they will not be taken without a fight.

The above Associated Press telegrams to The Times today give assurance that the officers are hot on the trail of the bandits. Sheriff Gage and Frank Gage left this morning for Allegany from where they will proceed to join in the hunt for the robbers.

There was a report current today that three deputies arrived in Marshfield this morning who have been after the men to head off any avenues of escape in this direction. It was stated that the bloodhounds were having trouble following the trail but they are certain that the men are headed southward and will doubtless soon be captured.

FINED \$50 FOR HIS PIGEONS

Another Heavy Penalty Assessed For Game Law Violation.

NORTH BEND, Ore., June 21.—Charles Groch was arrested here yesterday by Game Warden Cy Noah on the charge of killing wild pigeons out of season, and when taken before Justice of the Peace Shuster this morning entered a plea of guilty and was fined \$50 and \$10 costs.

Groch's arrest was brought about through the work of S. Powell, the deputy warden from the office of Master Game Warden Finlay who arrived from Salem recently. Powell caught Groch in the act of shooting the pigeons, but said nothing at the time. To elude the evidence against Groch he seized a box of pigeons marked eggs on the wharf at North Bend, which it is alleged was consigned by Groch. His heavy fine was partly occasioned by his first pleading "not guilty" and announcing that he would fight the case. Later he changed his plea to "guilty."

UNDERWOOD BILL IS PASSED

By a Vote of 221 to 100, the House Passes the Wool Tariff Bill.

WASHINGTON, D. C., June 21.—The House passed the Underwood wool tariff revision bill by a vote of 221 to 100, a number of republican insurgents voting with the democrats. In a special message to the House or representatives today, President Taft stated that the tariff board would not be ready to submit a comprehensive report on the woolen and cotton schedules until December next. The President's message was called out by a House resolution requesting him to transmit at once all information procured by the tariff board relating to wool. President Taft included in his message a statement from the tariff board that all information now at hand had been sent to the committee on Ways and Means.

POSSE HOT ON TRAIL.

Idaho Bandit It Is Said Will Soon Be Captured.

POCATELLO, Ida., June 21.—That the capture of Hump Whitney, one of the two desperadoes who killed Conductor Kidd and wounded Deputy Sheriff Milton, and who while eluding a posse shot two other men, is but a number of hours away it is said. A posse of 20 armed men, and some blood hounds are hot on his trail near Iona, Fremont county.

LORIMER CASE IS STARTED

Cyrus McCormik of Chicago Is Witness But Gives No Real Testimony.

WASHINGTON, D. C., June 21.—There was little but hearsay evidence brought out today when Senator Lorimer's investigation committee held its initial hearing in the inquiry on the charges of corruption in the election of the junior senator of Illinois. Cyrus H. McCormik, president of the International Harvester Company, was before the committee to tell what he knew of the collection of a \$100,000 slush fund alleged to have been used in Lorimer's behalf. He testified that Clarence S. Funk, general manager of the company, had told him of the activity in behalf of Senator Lorimer and that their correspondence had been invited by Edward Hines of the Hines Lumber Company to contribute to the election fund.

TAFT SENDS A SPECIAL MESSAGE

KILLED BY A LIVE WIRE

QUACK DRUGS ARE ATTACKED

Sherley of Kentucky Introduces Bill to Provide Against Fake Medicine.

WASHINGTON, D. C., June 20.—Representative Sherley of Kentucky today introduced an amendment to the pure food and drugs act providing against the false misleading statements of curative value in a medicinal preparation on the patent medicine label he prohibited. The "Bill," Sherley said, "is intended to make the pure food law embrace those cases of interstate shipments of worthless medicines and drugs fraudulently held out to the public as possessing curative properties."

CRUISER BOSTON WILL BE ON COOS BAY SOON

Lieut. Straw Receives Positive Assurance From Adjutant General Finzer.

Lieut. E. E. Straw arrived last evening, being the advance guard of the Coos Bay naval militia who returned on the Breakwater in command of Lieut. Thayer Grimes. Lieut. Straw was enthusiastic over the trip and says the Coos Bay contingent acquitted themselves with honor. They won many encomiums and especially from Lieut. Griswold, who is aide to Admiral Coffman and who accompanied the militia on the cruiser Boston from Bremerton Navy Yards to Portland.

Other good news brought by Lieut. Straw was assurance that the cruiser Boston would be brought to Coos Bay about the latter part of August for a six weeks or two months stay and perhaps longer.

The following telegram was waiting on his arrival:

"Lieut. E. E. Straw, Marshfield, Ore.

"This is to assure you that the cruiser Boston will be stationed at Marshfield during the latter part of the summer or early fall of 1911. (Signed) FINZER, Adjutant-General."

The reason the Boston was not brought at this time was because of high winds and an inexperienced crew might encounter difficulty.

AMENDMENT DEFEATED.

Bristow's Suggestion About Senatorial Direct Vote Is Rejected. (By Associated Press to Coos Bay Times.)

WASHINGTON, D. C., June 21.—By a strict party vote of 172 to 113 the House refused to accept Senator Bristow's amendment to the resolution providing for direct election of United States senators.

A NEW RUN TO SAN FRANCISCO

Alliance May Be Put on Regularly Between Portland, Coos Bay and San Francisco.

Agent C. P. McGeorge of the Alliance Steamship Company, received a telegram from C. P. Doe, general manager of the Northern Pacific Steamship Company, announcing that the Alliance would make a special trip from Eureka to San Francisco. On her return trip the Alliance will leave San Francisco on Saturday next, arriving in Coos Bay Monday afternoon. The Alliance is now on her way to Eureka, and will thence proceed directly to San Francisco.

Agent McGeorge is not advised as to the reasons for the interruption in the Portland schedule of the Alliance but in shipping circles it is taken to mean the possibility of another boat being added to the Coos Bay run by the Northern Pacific Steamship Company. The steamer Kilbourn of the North Pacific fleet will be in commission July 1, and steamship men point to the possibility of the Alliance run being extended to San Francisco and the addition of the Santa Clara to the Coos Bay fleet on the same run. This would give a greatly improved San Francisco steamer service.
