

#### Expect That Both Water and Waterfront Railway Fran-

chises Will Come Up.

The regular meeting of the Marshfield city council tonight promises to be enlivened by discussions over the water franchise and the street car or waterfront railway franchise besides a number of other matters.

The return of Mr. Nolan who has been negotiating for the local waterworks system and for the new fiftyyear water franchise is expected to be for the purpose of personally trying to get the council to consider his application which has been generally regarded as unreasonable. No official statement has been given out by Mr. Nolan regarding his plans.

It was rumored today that Francis H. Clarke, head of the Coos Bay and Boise Railway project, would ask for a waterfront railway franchise similar to the one sought by the other local men. This could not be confirmed. F. A. Haines, chief engineer of the company, said that he doubted the report as he had not been apprised of any such intention. 


