RAPID TRANSIT CHARTER LOST

North Bend City Council Revokes Franchise Given Major Kinney's Company

The North Bend city council at its meeting this week passed a resolution revoking the street car franchise which was granted the Coos Bay Rapid Transit company during Major Kinney's last operations. There was very little discussion over the matter. It is presumed that this action was preliminary to taking up an application from the C. A. Smith company, the Simpson Lumber company, W. S. Chandler and Flanagan & Bennett for a franchise similar to the one granted in Marshfield last night. The North Bend charter provides that all corporations holding franchises must pay an income tax on their earnings and whether an attempt will be made to have the charter amended to eliminate this remains to be seen.

The North Bend council also ratified the action of the special water committee in securing Engineer Richardson to provide plans for a municipal waterworks system for Marshfield and North Bend and arranged to pay two-fifths of the cost of his work. Marshfield paying three-fifths. The committee was continued. City Recorder Derbyshire was instructed to ascertain what steps would be necessary to have the Oregon Railroad commission appraise the value of the present company's plant.
