

NOTICE OF DELINQUENT TAXES FOR THE YEAR 1910.

In accordance with Chapter 275 of the 1911 General Laws of Oregon which is in substance as follows:

SECTION 1. Four months after date when taxes charged against real property are delinquent, the tax collector shall cause to be published once each week for four successive weeks, in the newspaper or newspapers selected by the county court to publish county court proceedings under the provisions of Section 2902 of Lord's Oregon Laws, a notice stating a description of the several parcels of real property upon which taxes are delinquent, the amount of taxes, and the name of the owner, if shown upon the tax roll, and a statement that six months after such taxes are delinquent a tax certificate of delinquency will issue therein, as provided by law. Such notice shall be published for a price not exceeding the price prescribed by Section 2903 of Lord's Oregon Laws. The tax collector shall forthwith cause to be posted a copy of the printed notice in four public places in his county for four weeks, commencing four months after the date when such taxes become delinquent, and shall file in the office of the county clerk of his county a copy of such notice, with a certificate endorsed thereon setting forth that such notices had been posted in four public places in his county, as hereinbefore provided.

SECTION 2. The neglect or failure of the tax collector to give such notice in the manner herein provided shall not invalidate any tax certificate of delinquency, but shall subject the tax collector to any damages which may be sustained by any party injured by the failure to give such notice.

SECTION 3. The cost of publishing such description shall be added to and become a part of the penalty charged against the particular tract of real property.
