**Buy Land**—Louis Hagstrom yesterday through August Frizeen purchased ten acres of land near Coos City from Dick Noble. He bought it as an investment.

**Go to Portland**—Instead of returning direct to Coos Bay from San Francisco, Mr. and Mrs. R. M. Jennings went to Portland for a brief stay. They are expected home this week.

**Alliance In**—The Alliance arrived in late this afternoon from Eureka, having been delayed by the rough weather off the coast. It is expected that she will sail this evening for Portland.

**Enjoy Smoker**—The members of the Marshfield fire department held an enjoyable smoker at their hall last evening. It was purely a social meeting, no business of any kind being taken up. Stories and impromptu talks were followed by refreshments.

**Bar is Rough**—The Coos Bay bar is showing the effects now of the severe storm that has been raging off the coast the last couple of days. About noon yesterday it got very rough and the Nann Smith has been unable to go out and is now waiting in the lower bay for the storm to subside.

**Finds Dog**—Otto Schetter has finally recovered his dog "Beans." The canine had wandered over to Eastside and forgot to come back, some one there picking "Beans" up as a stray and giving him a new home. However when the dog heard Mr. Schetter's voice he indicated a strong desire to return.

**Take Evidence**—Evidence in the case of E. W. Bernitt and E. Wittig vs. the Smith-Powers Logging company, involving the ownership of the booms on lower Coos River, is being taken in Judge Hall's office today. W. T. Merchant was one of the witnesses called. The case is pending in circuit court.

**Closed Till Monday**—Owing to the waste burner at the Smith mill having sprung a bad leak, the mill has been closed down until Monday. It was expected yesterday the repairs could be effected today to start operations tomorrow but the repairs were more difficult than were first anticipated and so the longer delay.

**Wins Claim**—Advices have been received by John D. Goss that John Negithon of Kentuck Inlet has won his homestead there. Negithon had lived on the ranch for many years, but through error had failed to prove up on it. Geo. Farrin noticed it and filed on it and later Farrin sold his relinquishment to Mr. Horn of North Bend. Negithon instituted a contest and has won out.

**Tries Case**—Before Justice Penock this afternoon, the case of B. F. Rabskopf vs. A. M. Ross for one-half of a \$175 real estate commission is being tried. Ross maintains that the sale was made after he and Rabskopf dissolved partnership and that consequently the latter is not entitled to any commission on it. Rabskopf says the sale was made on an option secured while he was a member of the firm. The jury hearing the case is composed of Geo. W.

**Quits School**—As a result of the troubles in the Empire school, Mr. Thompson, the teacher, has resigned. He wanted to quit today but the substitute he secured was not satisfactory to the board and he may have to continue for a few days. **SANTA CLAUS MAIL WILL BE DELIVERED**

Postmaster Curtis has received the following official order, which is self-explanatory:  
"Order No. 5874—Postmasters are authorized to deliver all letters arriving at the respective postoffices between December 16, 1911, and January 1, 1912, inclusive, which are addressed plainly and unmistakably to 'Santa Claus,' without any other terms or expressions identifying the person for whom such letters are intended, to responsible institutions or individuals in the town or city of address, who may desire to use them exclusively for philanthropic purposes. In the event that these letters are requested by more than one institution or individual, the postmaster shall distribute them in such proportion as he may deem proper."
