PORTLAND, Org Jan. 1-Through the efforts of John P. Sullivan, the Grand Exalted Ruler of the Elks, conflicts in the dates of the important conventions of 1912 have been avoided.

As soon as it was decided that the Elks would hold their annual reunion in Portland during the week of July 8, Mr. Sullivan conferred with officials of the Grand Army and the Shriners with the result that the conventions of those organizations will be held in Los Angeles in September and May respectively.
