Representative Lindborgh of Minnesota Has New Plan for Dealing With it.

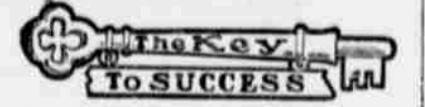

C., April 9.—The charge that Wall street and the big corporation are controlling the House in the "money trust" inquiry was made today by Representative Lindborgh of Minnesota, a republican, in a resolution which would compel every member to disclose his business and corporation affiliations. Each member of the House would have to file his own bank holdings and those of his family and the names of the members who failed to do so would be published in the congressional Record "Black list."

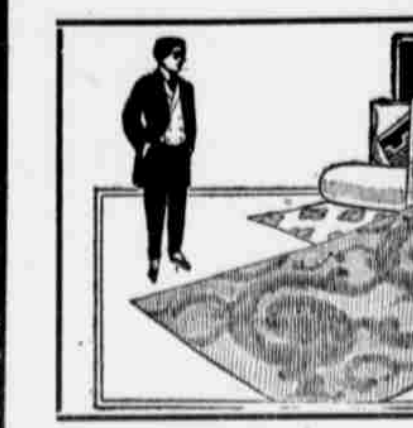
