SOUPS

FLAKED PEAS

A small handful of Flaked Peas added to any soup, fifteen minutes before it is ready to serve, will greatly improve its flavor and wholesomeness.

PUREE OF FLAKED PEAS

3 cups of beef stock
1/2 cup cold water
1 1/2 tablespoons catsup
Tiny piece of garlic

1 cup Sperry Flaked Peas
1/2 medium onion
1/2 tablespoon Worcestershire
Sauce
Salt to taste.

Boil onion in stock until tender, add catsup, Worcestershire, garlic, dash of white pepper and salt; then add the flaked peas. Cook slowly 20 minutes, strain and serve with croutons. Stick onion with whole cloves.

COPIES OF OLD PAPER FOUND

Interesting Volumes Discovered Among Effects of the Late David Morse.

A number of copies of "The Rustle," one of the first papers published in Coos County, have just been secured by A. E. Morton. The papers were preserved by the late David Morse of Empire and were given to Mr. Lennan of North Bend, Mr. Morton's father-in-law.

The paper was published at Empire and the first copy is dated September 1, 1871. The name of the editor is not given. Besides this publication, there are a number of copies of another paper, "The Humblebee," which was published at Empire a few years later.

One of the first issues of "The Rustle" contained the following article on the railroad situation, showing that the present agitation had its start over forty years ago:

"THE RAILROAD."

"Any person acquainted with the typography of Coos county must know that the lumber and coal regions on and around the bay most entirely depend, for hay, grain and vegetables upon the San Francisco market, while at the same time we have within the county a large scope of farming lands unsurpassed by any country, which cannot be made available for the simple reason that in this county the chief consuming and producing portions are unconnected by anything more than a trail, the transportation over which would exceed the cost of produce in San Francisco. He must also know that the navigable waters of Coos Bay and of the Coquille River at the nearest point are but eight or ten miles apart and that the highest point between the two does not exceed seventy feet, making natural grade for railroad, and making the cost of a narrow gauge road trifling compared to the advantages to be gained. From the moment such a road went into operation a new era would dawn upon Coos county. That is all it needs for it to take rank among the first of the state as an agricultural county as it now is for coal and lumber. It would insure a good price for all home and farm products and save thousands of dollars to the people of the county annually that now finds its way to the markets of California—that leech that has fattened upon the sustenance drawn from Oregon for years. The subject is now being agitated; let every one consider it and move on in the work. Our legislatures have spent thousands of dollars on public works not as necessary as this, and but little has been done for this portion of the state. We have a right to expect state aid and will undoubtedly get it; if not let us see who is in fault and reward accordingly. I would here say that the County courts are also taking into serious consideration the construction of a wagon road connecting Empire City with the Coquille country. Things are moving in the right direction, let no penny wise and pound foolish economy stop the good work."
