DEVOTED WOMEN.

REATER than the chivalric story of the men who went down with the ship in order that the lifeboats might be filled with women and children is the tale of devotion of those women who refused to leave their husbands and gave up their chances of escape in order to stay

with their loved ones. Many newspapers throughout the world are commenting upon the wifely devotion shown by Mrs. Isadore Straus and other women who refused to enter the boats though they had opportunities to do so.

In De Morgan's best story the climax is attained at the crisis when, in a steamship disaster like that of the Tftanic the young wife refuses to go in the boats, declaring that she will live or die with her husband, says the Pittsburg Dispatch. To most men the natural law that their wives and daughters should be saved from danalmost beyond reality. But the sinking of the Titanic presents not one, but several cases of this heroic choice of wives to die with their husbands rather than leave them.

The case of Mr. and Mrs. Isadore Straus was the most notable. When Mrs. Straus found that her husband would not be allowed in the boat she stepped out of it, preferring to die with him rather than live without him. A Mr. Allison is reported to have been accompanied by his wife and daughter, and they refused to be reacued rather than let him die There are indefinite reports alone. of a dozen similar cases, all of them representing a brillant example of love and self-sacrifice that is a bright contrast to the matrimonial faithlessness that furnishes commonplace sensations.






