

C., July 30.--The Senate has adopted an amendment to the sundry civil bill, pro-posed by Senator Borah, providing that homesteaders who made filings prior to June 6 last may perfect title under the three-year or five-year homestead law, as they prefer, even though they fail prior to October 4 to elect under which law they will proceed.
