OPPOSITION FOR PANAMA CANAL BILL IS ANTICIPATED

That Administration Sanction Pending Measure.

MAJORITY VOTE WILL BE TAKEN TODAY

Think That Broadening of Registration Provision Will Help Marine.

Associated Press to The Coos Bay Times. WASHINGTON, D. C., Aug. 9.—The Senate's amendment to the Panama Canal bill to admit to United States registry American owned foreign built vessels engaged in foreign trade only and pass them through the canal free of tolls in all probability will receive no opposition from the administration. Secretary Nagel who is committed to this idea believes it will be the beginning of an American marine. With the vote on the bill and amendments set for five o'clock this afternoon, the Senate began final consideration of the measure with the fight against the railroad owned ships.

CANADA ALSO ANGRY

British Columbia May Not Participate in Fair.

(By Associated Press to The Coos Bay Times) VANCOUVER, B. C., Aug. 9.—As a result of the action of the Senate in regard to the Panama canal tolls, British Columbia may decline to participate in the Panama Pacific Exposition. The feeling engendered is bitter, a fact which was emphasized by a statement of A. B. Erskine, president of the Board of Trade, when he received a dispatch from London, stating that Great Britain might also withhold her support to the fair.

STUBBS WINS KANSAS TOGA

Governor, Follower of Roosevelt, Said to Have Beaten Curtis for Senator.

TOPEKA, Kan., Aug. 9.—With returns from all of the 105 counties of Governor Stubbs today wins his nomination for United States Senator in Tuesday's primary. The returns indicate that he carried 77 of the 105 legislative districts. The democratic senatorial nominee, Wm. H. Thompson probably is an ardent Roosevelt man and was pitted against Senator Curtis, a Taft man. The Roosevelt supporters won out practically all along the line Tuesday.

RESULTS IN IDAHO.

Republican Leads Haines for the Republican Nomination. BOISE, Idaho, Aug. 9.—With the final returns of nine counties missing, Cagstone is leading Haines for the Republican nomination for governor by 1450 votes. Two of the remaining counties are thought to have given Haines a large vote.

Despite Denials of Police Lieutenant, Prosecutors Hope For It.

Becker is on the verge of breaking down and although there are reports to the District Attorney office that the police officials under indictment for Gambler Rosenthal's murder might turn state's evidence, Becker himself in a statement issued this morning denied the truth of the reports that he contemplates a confession. He said that he had no confession to make "for the simple reason I have nothing to confess."

DETROIT HAS NEW SCANDAL

Twenty Aldermen to be Arrested on Charges of Conspiracy and Bribery.

DETROIT, Aug. 9.—Sensational developments in the local aldermanic graft scandal occurred today when Prosecuting Attorney Shepard announced that before night about 20 aldermen will be arrested on charges of conspiracy to defraud the city in connection with their official positions. Nine aldermen were recently arrested on similar charges and also are included among the 20 new arrests. It is said the arrests are to be based on entirely different evidence than that which led to the arrest of the nine aldermen and the secretary of the common council who are now at liberty on bail facing charges of receiving and conspiring to receive bribe money for giving the Wabash railroad city property for building purposes. The prosecutor said he had struck many new evidences of graft. The Superintendent of Police had made 15 arrests before noon. Those newly arrested were required to furnish \$5,000 bonds and those who are under arrest in connection with the previous charge were released on additional bail of \$2,000.

Stock of Dissolved Trust Goes to Record Price on Curb NEW YORK, Aug. 9.—The old stock of the Standard Oil company of New Jersey which includes all the subsidiaries, sold on the curb recently for \$1,000 a share, a high record price. At this figure the market valuation of the old company is one billion.

HAVE EIGHT CAMPS

Porter Brothers Rush Work West of Eugene The Eugene Guard says: "Porter Brothers, who have a sub-contract to build 80 miles of the Coos Bay railroad west of the Noti tunnel, have already established eight camps along the line. Big loads of supplies are leaving Eugene every day for the camps. Passengers coming in on the Sluslaw auto stage last night report that they met 18 freight teams, most of them four-horses to the wagon, hauling material for railroad construction work west of the city."

WHEAT CROP BETTER THAN USUAL

Government Report Shows It to be Ten Per Cent Ahead of Ten-Year Average.

(By Associated Press to Coos Bay Times) WASHINGTON, D. C., Aug. 9.—The August crop report of the crop reporting board of the Department of Agriculture issued today shows the condition of corn to be 80 per cent of normal, compared with the 82.8 per cent average for ten years.

Spring wheat is estimated at 80.4 per cent compared with a ten year average of 80.3 per cent. It is estimated that the total production of winter wheat will be 390,000,000 bushels. The estimated yield per acre of winter wheat is 15.1 bushels. Its early condition was 89.1 per cent. The condition of flax is 87.5 per cent and the production 28,000,000. The hay production is 91 per cent and the production 73,000,000 tons. Apples condition was 65.8 per cent.

MEX. BANDITS CROSS BORDER

United States Troops Ordered Out to Stop Raiding in Texas.

TO KEEP OPEN LOAN OFFICES

Continental Building and Loan Association Enjoins State Officer.

SAN FRANCISCO, Aug. 9.—Superior Judge Graham issued a temporary restraining order today preventing the Building and Loan Commissioner Walker from interfering further with the affairs of the Continental Building and Loan Association until after settlement in the courts of the difficulties of the association, which yesterday was declared insolvent by Walker. The order is returnable Monday. Walker had announced his intention of closing the offices of the association today but was prevented by the issuance of the injunction.

BORDWELL IS WITNESS NOW

McNamara Trial Judge Denies Lincoln Steffens' Claims On Stand.

LOS ANGELES, Aug. 9.—Judge Bordwell, who presided at the McNamara trial, was called today as a witness in the Darrow trial to impeach the testimony of Lincoln Steffens, the magazine writer. Steffens testified that he had informed Judge Bordwell of the negotiations for a compromise plea in the McNamara case. Bordwell today denied that Steffens ever discussed the matter of pleas prior to the pleading of the McNamaras. According to Bordwell, Steffens tried to discuss the matter with him, but he refused, warning Steffens that he could not talk about the case. On cross examination Bordwell corroborated the testimony of Steffens that the latter had shown him an article in a local newspaper prior to its publication to which he had suggested alterations.

FAMILY CAT CAUSE OF FIRE

Man Steps on Feline, Drops Lamp, and House is Burned PORTLAND, Ore., Aug. 9.—When Louis J. Lafayette, of 1175 Lieber street, a brakeman, stumbled over the family cat and dropped a lighted oil lamp, a fire was started which made homeless himself and his wife. The house was burned to the ground. No water facilities were in the neighborhood and nothing could be done to save the place. The cat was burned to death. When frightened, it sought refuge in the fireplace of the house, and would not come out in response to the calls of its mistress. Lafayette places the value of his house, furniture and personal belongings at \$1,500 with \$900 insurance.

CHICAGO CAR STRIKE LIKELY

Street and Elevated Railway Employees Threaten to Walk Out Soon.

NAVAL VESSELS ARE DAMAGED

Battleships Nebraska and Connecticut Meet With An Accident.

WASHINGTON, D. C., Aug. 9.—The battleship Nebraska ran on an uncharted shoal near Newport, R. I., last night and was so seriously damaged that she has been ordered to drydock at the Boston navy yards. The flagship Connecticut broke her starboard crank shaft about the same time and has been ordered to Philadelphia for repairs. It is believed that the damages to the Nebraska are serious, but those of the Connecticut are not serious. An investigation will be started once about the location of the uncharted shoal, which was a great surprise to the naval officers.

TAFT VETOES WOOL TARIFF BILL SECOND TIME TODAY

PRINT THREE SPEECHES NOW

Senate Grants Requests About Campaign Literature of Parties.

WASHINGTON, Aug. 9.—The Progressive Party made its formal bow today in the senate, when Senator Poindexter, as a member of the new party, asked that Colonel Roosevelt's Chicago speech be printed as a public document. This request was followed by one by Brandegee that Root's speech of notification and Taft's speech of acceptance be printed as a public document. Culberson asked that James' notification speech and Wilson's acceptance be printed as another document. All three requests were granted.

NORTH BEND TO HAVE TWO MEN

Indorses Simpson and Armstrong for Commissioners Eastside Plans.

At a meeting of the North Bend Commercial Club last evening, L. J. Simpson and Herbert Armstrong were endorsed as North Bend's candidates for Port Commissioner. The action was taken following a request from citizens of Cooscon and vicinity that steps be taken to apporportion the commissioners to the different parts of the district. There was a good attendance out and port matters were discussed at length. Dr. Bartle, president of the club, presided. Messrs. Simpson and Armstrong were the only ones considered. C. S. Winsor who had been previously talked of having decided not to be a candidate. Dr. Bartle, Peter Loggie and Geo. D. Mandigo were named as a committee to confer with the Marshfield Chamber of Commerce about having the latter body indorse two candidates as Marshfield's share of the commission. The idea was for North Bend to have two, Marshfield two and the outlying districts one member of the commission. Residents of Eastside are also desirous of having a member of the Port of Coos Bay Commission. They have been discussing the matter at length among themselves and have called a mass meeting to be held at the city hall there next Monday night to take definite action. C. E. Jordan, R. J. Montgomery, F. J. La Palme and others have been suggested as the Eastside candidate for the place.

FOR JAIL SENTENCES

Violators of Sherman Anti-Trust Law to Get Worse than Fines (By Associated Press to The Coos Bay Times.)

President Turns Down Proposed Revision of Schedule K by Congress.

SAYS BILL DESTROYS INDUSTRY PROTECTION

Steel Bill, Cotton Bill, Sugar Bill and Excise Bill to Get Axe Also.

(By Associated Press to Coos Bay Times.)

WASHINGTON, D. C., August 9.—For the second time within a year, President Taft today vetoed the bill to revise the wool tariff schedule "K" of the Payne-Aldrich law. The President returned to Congress the bill evolved as a compromise between the House and the Senate, holding that the low rates provided in it would bring disaster to home industry. He appealed to Congress, however, not to adjourn until it had enacted a measure to substantially reduce unnecessary existing duties "without destroying the protection for the wool industry in the United States."

The President's disapproval of the wool bill is to be followed by similar vetoes of the steel bill and cotton bill. The sugar bill is likely to be vetoed as is the excise tax bill, the latter probably on the ground that the President believes it unconstitutional. Unlike the veto of the bill a year ago which is identical with the vetoed today, the president assigns a different reason. He vetoed the former because it was framed before the tariff board made its report. He vetoed the present bill because it was framed in disregard of the board's findings. President Taft reiterates his support of reduced tariffs but only in case the protective tariff system shall be maintained.

RELATIVES OF VICTIMS HERE

H. Lorenz of Coquille and Mrs. Ben Smith of Marshfield Get Sad News.

The Associated Press dispatch in The Times yesterday concerning the murder of the Gould sisters near Weaverville, Calif., is of considerable interest in Coos county because Wm. Lorenz, the step-father of the victims, is a nephew of H. Lorenz of Coquille. George Lorenz, who was with the girls a short time prior to their murder and who has disappeared, is also a nephew of Mr. Lorenz.

Mr. and Mrs. E. Bandel of Marshfield who formerly lived in Trinity county, Calif., knew of the family and were much interested in the news. Mrs. Ben Smith, who resides at the Bandel home, had an uncle, Frank L. Dimmock, slain in Delta, Calif., last Saturday by bandits. The first news of it was received by her through an Associated Press dispatch in The Times.
