PANAMA CANAL BILL WILL EXTEND REGULATION POWERS

President Taft Says He Will Sign Measure That Senate Passed Yesterday.

BOURNE AMENDMENT IMPORTANT FEATURE

Empowers Commission to Divorce Competing Railway and Water Lines.

(By Associated Press to The Coos Bay Times.)

WASHINGTON, D. C., Aug. 10.—President Taft told callers today that he did not entirely approve the Panama Canal bill as it passed the Senate, he expects to sign it. Railroad and legal experts in Congress hold the Senate authorized a highly important extension of power of the Interstate Commerce Commission in adopting the Bourne amendment. This amendment would empower the commission to divorce competing railroads and steamship lines where ever they were found to operate to the detriment of the public and would extend the powers of regulation over the water lines never conceded the right of the commission to supervise their business or their relations with the railroads. Little difficulty is expected in reconciling the differences between the Senate and House on the bill.

NAMES SECRETARY KNOX

Will Represent United States at Mikado's Funeral.

WASHINGTON, D. C., Aug. 10.—Secretary Knox was designated by President Taft as special representative of the United States at the funeral of Mutsu Hito, the late emperor of Japan. He will leave here for the coast next Thursday, returning in October.

Sec. Knox will go by way of Seattle. It is admitted at the State Department that while in Japan, Sec. Knox will talk with the Minister of Foreign Affairs. A rear admiral and a major general will probably be assigned as aides to Sec. Knox.

BIG STEEL ORDERS

Ordered Tonnage Nearly Double What it Was Year Ago.

NEW YORK, Aug. 10.—The unfilled tonnage of the United States Steel corporation July 31, totalled 5,950,000 tons tonnage while a year ago it was 3,580,000.

CLOSE IN KANSAS

Senatorship Result in Kansas May Require Official Count.

WASHINGTON, D. C., Aug. 10.—Senator Curtis on his return here today said that it probably would take an official count to determine whether he or Gov. Stubbs had carried the republican senatorial primary in Kansas.

Speakers report say the official returns that began coming in today indicate that Governor Stubbs not only won the republican senatorial nomination over Senator Curtis but a plurality of the legislative districts had the popular vote.

Ship Nebraska Being Conveyed To Port.

PASCO DESERT VICTIM FOUND

Edwin Hart Dies of Thirst While Trying to Cross Arid Waste.

PASCO, Wash., Aug. 10.—With the ground and sagebrush about it torn and scraped in a frantic search for water, the body of Edwin Hart, a sixty-year-old railroad laborer, was found Friday on the desert near White Bluffs by the coroner. Hart, who has been employed at Beverly, attempted about a month ago to walk to White Bluffs across the desert and carried no water.

PLAN TO PROBE LOAN AFFAIR

Grand Jury Investigation of San Francisco Building and Loan.

SAN FRANCISCO, Aug. 10.—The grand jury will investigate the Continental Building and Loan association which was declared insolvent Thursday by Commissioner Walker. The foreman of the grand jury called a meeting for Friday night for opening the investigation which it is said the inquisitorial body has decided to make a sweeping investigation and make recommendations for the criminal prosecution if any be warranted by the results. The depositors continued to appear at the offices of the association today and demand their money but were told no payments would be made until after the court settlement. They were assured the association would discharge its full indebtedness.

\$200 OFFERED FOR JOYNER

COUNTY COMMISSIONERS APPROPRIATE ONLY PART OF AMOUNT REQUESTED BY THE SHERIFF.

The Coos county commissioners have appropriated \$200 for Sheriff Gage to offer as a reward for the recovery of Bill Joyner, the South Slough rancher who disappeared a week ago. The reward is to be paid for recovery dead or alive.

Sheriff Gage asked for a reward of \$500 and is rather indignant because the commissioners cut the amount down. He does not consider that \$200 will do any good.

C. G. Hockett of Empire, who has been assisting Sheriff Gage investigating the matter is of the opinion that the reward should be \$500.

No trace of Joyner has been obtained but it is expected that the offer of the reward will lead to activity among South Slough residents in an endeavor to find the boy.

Many are stronger than ever under the impression that Joyner has merely jumped the country in order to avoid further investigation in connection with the Evans case, having been under the impression, according to some, that he was being shadowed by detectives.

HORRIBLE BUTCHERY IN BULGARIA

Turkish Officials Calmly Watch Mussulmans Slay Victims in European Turkey.

USKAP, European Turkey, Aug. 10.—Details of the massacre of Bulgarians at Kotschana by Mussulmans

August 2 show the butchery lasted three hours and more than 140 Bulgarians were killed. The trouble began with an explosion in the crowded square of a bomb, five Bulgarians and six others being killed. A few moments another bomb was exploded and Mussulmans armed with guns and revolvers, knives and clubs began the butchery with Turkish officials looking on.

MAJOR WINS IN MISSOURI

COMMITTEE IS SCORED

Senator Pomere Gets Action on Anti-Trust Resolution

WASHINGTON, D. C., Aug. 10.—Immediate action on his resolution to instruct the attorney general to bring criminal prosecutions against officers of the Standard Oil company and the American Tobacco company was asked by Senator Pomere today. He also asked to have the judiciary committee before which the resolutions have reposed for more than a year discharged from further consideration of the resolution. He finally withdrew his request on the committee's promise that he should have a hearing Monday.

POLICE ARE ACCUSED

MUSIC TEACHER FOUND SLAIN

Sigma Carizen Victim of Fiend In Suburb of Denver Late Yesterday.

DENVER, Colo., Aug. 10.—The body of Miss Sigma Carizen, 25 years old, was found in a clump of woods in Aurora, a suburb of Denver, today. Apparently the young woman was murdered by a blow that crushed her skull. Stockings were tied around her neck and a cloth stuffed into her mouth presumably for the purpose of preventing an outcry.

Miss Carizen is said to have been mistreated before the murder. There is no clue to the murderer. Miss Carizen was a music teacher. She was last seen yesterday evening when she left a pupil's house to take a car for Denver.

LORENZ KILED HIMSELF

Nephew of H. Lorenz of Coquille Found Dead Near Murder Scene

WEAVERVILLE, Cal., Aug. 10.—The body of George Lorenz, with the top of his head blown off, was found beneath a pine tree, 300 yards from the scene of the murder of Kate and Elba Gould, sisters, 13 and 16 years old, whose bodies were found at their home at Steiner's Flat. Lorenz, who was a brother of the girl's step-father, and the rejected suitor of Elba Gould, used a rifle in taking his own life. The girls had been killed with an automatic pistol. The three bodies were sent to Weaverville.

The Lorenz family came here from San Francisco three months ago and were joined a few days ago by George Lorenz. Friends noted his strange actions and comment was made freely regarding his infatuation for the older sister. William and George Lorenz are sons of a pioneer family of this county. Mrs. Lorenz is the owner of the Hotel Lorenz in Redding.

FEAR BORDER TROUBLE NOW

Gov. Colquitt of Texas Notifies Secretary of War That He Will Act.

AUSTIN, Tex., Aug. 10.—The secretary of war today sent an answer to the message of Governor Colquitt which described the raiding of Mexicans along the border. Governor Colquitt declared that if the United States did not protect the people of Texas, the governor would order out the state troops to intercept the marauders and drive them back across the border. Sheriff Edwards of El Paso county has wired the governor that several bands of the Mexicans have crossed the border and that mounted men will be required to control them. Four troops of state cavalry are at New Braunfels awaiting the governor's orders.

TO PROTECT AMERICANS.

United States Soldiers Will Guard Property Near Border.

SAN ANTONIO, Tex., Aug. 10.—One troop of United States cavalry was sent from Fort Sam Houston today to Sierra Blanca and a squad from Fort Clark was sent to Del Rio to protect American interests there.

DENIAL BY OROZCO

Mexican Rebel Leader Says He Made No Peace Overtures.

JUAREZ, Aug. 10.—General Orozco on reading a dispatch from Mexico City that he had made overtures for peace provided that he be allowed to escape from Mexico, made a flat denial today of the whole story. He maintained that he had made no peace proposals, that the report was a ruse to create the impression that he was weak and pronounced the statement was false that he ever admitted a lack of power to command his leaders.

MILITIA SHOT BY A FARMER

Three Illinois Guardsmen Are Wounded by Man Whose Place They Crossed.

WOULD ALLOW ONLY SIX YEARS

SHIP CASCARA BARK

Coquille Valley Will Receive \$10,000 This Fall

The Coquille Sentinel says: "Cascara bark shipments from the Coquille Valley this year will not be greatly in excess of last seasons' output. The bark is plentiful as in former years but the market has been poor and only a few who had their crop contracted for were able to get a satisfactory price. George Moulton, probably the largest shipper of the product in the valley, says the output will not go over 100 tons, and will bring the various producers not over \$10,000. The peeling is done by boys who find it a very profitable way to earn school money during their summer vacation. Although the work is somewhat strenuous a good "peeler" can make an average of \$5 per day."

QUAKE DESTROYS Large Number Killed and Injured in Disaster Near the Dardanelles Today.

NARROWEST PART OF PENINSULA SHAKEN

Relief Ship Hastened to Scene by Turkish Government This Afternoon.

CONSTANTINOPLE, Turkey, Aug. 10.—Gallipolis, 132 miles west of here, and the town of Tchanak Kalesi at the narrowest part of the Dardanelles, have been destroyed by an earthquake and many inhabitants killed or injured.

The inhabitants of several villages are homeless and without food. A steamer has been chartered and a torpedo boat ordered to go to their relief.
