



ROSCOE IN TROUBLE.

Tug Loses Propeller Blade, After Leaving Dry Dock.

The tug Roscoe which makes frequent trips between Coos Bay and the Siuslaw river, had an accident in Portland, according to an account in the Journal:

While leaving the dock of the Willamette Iron and Steel Works yester day afternoon, after being remodeled in her engine room, the Coos Bay tug L. Roscoe broke a propeller blade and had to be turned back to the Oregon dry dock to have a new wheel ship-

The Roscoe has been at the iron works for the last three weeks or so having an oil burning plant installed. That work has been completed and she was just leaving for Coos Bay, when her propeller fouled in something and a blade was broken off.
