VICE-PRESIDENT SHERMAN IS DEAD BALKAN TROOPS ROUT TURK ARMY AFTER HARD BATTLE

Succumbed Late Last Evening at Home in Utica—Funeral Will Be Held Saturday.

(By Associated Press to The Coos Times.)

UTICA, N. Y., Oct. 31.—Vice President James Sherman of the United States and candidate for reelection with President Taft on the Republican ticket, died at the family home here at 9:42 last night.

Utica is mourning today over the death of Vice President Sherman. Bright's disease complicated with disease of the heart and hardening of the arteries, following a period of more than 24 hours of almost total unconsciousness, were given today as the causes of death.

Sherman was a prominent factor in many business enterprises in this city and the offices of such concerns are closed for the day.

Excited public functionary though he was, he was known to Uticans as Jim Sherman. Indeed, by most people, the surname was dropped and the common exchange of salutation among the older residents of the city today was "Poor Jim is gone."

Condolence from men and women in all parts of the country were received today. They include telegrams from Taft, Roosevelt, Wilson, Marshall, and most of the men in public life.

Mr. Sherman had been ailing for a long time, but his condition did not reach a critical stage until a few days ago when acute kidney trouble developed in connection with other complications.

With the end in view of obtaining a larger auditorium, the first decision to hold the funeral of Vice President Sherman in the Reformed Dutch church was abandoned.

The service will be at 2 o'clock Saturday and will be conducted jointly by Dr. Holden, pastor of the Dutch church, and Dr. M. W. Stryker, president of Hamilton College, of which college Sherman was an alumnus.

TRIBUTE BY MARSHALL. Democratic Candidate Cancels His Speaking Dates.

"Mr. Sherman is not alone the dead of one of the contesting political parties but is the nation's dead as well and as such is deserving of the honor and respect of every man who respects the nation."

LARGE SUMS FOR CAMPAIGN

Contributions to Republican National Fund Last Week Totalled \$153,655.

WASHINGTON, Oct. 31.—Contributions amounting to \$153,655.92 were received by the Republican national headquarters last week, according to a supplemental report filed today with the clerk of the house by George R. Sheldon, treasurer of the Republican national committee.

The report is in compliance with the statute requiring supplemental reports every six days after the first report. The report shows the contributions were received between Oct. 20 and Oct. 25.

During the last six days the Democratic national committee received \$136,688.72 in contributions, and borrowed \$40,000. During this period the total expenditures amounted to \$265,445.20.

"TIPPED OFF" M'NAMARAS

Herbert S. Hockin Told Detective Burns Details of Times Dynamiting.

(By Associated Press to The Coos Bay Times.)

INDIANAPOLIS, Ind., Oct. 31.—Sensational testimony that William J. Burns, the detective, was "tipped off" as to the identities of the dynamiters of the Los Angeles Times building, two weeks after the explosion, by a man now on trial, was given at the dynamite conspiracy trial today.

J. A. G. Badoff, a special investigator investigating the cause of the explosion for five years, testified that Herbert S. Hockin admitted to have "gotten in touch" with Burns.

Burns was in Los Angeles soon after the explosion October 1, 1910. The McNamara brothers and Ortle McManigal were arrested six months later, after ten more explosions had taken place. Badoff testified that Hockin made the admission after he said to Hockin, "You are a fool for giving all your information and letting him build up a reputation on information you give. If you expect immunity why don't you go to District Attorney Miller."

The witness said that Hockin, who was the secretary of the International Association of Bridge and Structural Ironworkers, admitted he contemplated pleading guilty.

Sultan's Soldiers Forced to Retire After Three Day's Struggle.

THINK INTERVENTION WILL SOON FOLLOW

European Powers Not Likely to Permit Occupancy of Constantinople.

(By Associated Press to The Coos Bay Times.)

SOFIA, Oct. 31.—The Bulgarian army completely routed the main Turkish army under Nazim Pasha. The Turks fled in disorder, leaving many killed and wounded on the field.

The battle which is regarded as the most important engagement since the beginning of the war, lasted three entire days. It extended along the line from Luele Burgas eastward to Serai. The Turkish front was over 31 miles long. The Ottoman troops retreated to Tchorlu, about 21 miles to the south of the positions from which they were driven by the Bulgarians.

The town of Tchorlu, where the Turks are expected to make another stand occupies an important position on the main road and on the railway between Constantinople and Adrianople at a point where the road from the port of Rodeosto joins. Unless the Turks hold this place they will be unable to bring any more troops from Asia Minor by way of Rodeosto.
