PLAN TO CRUSH CASTRO REVOLT

Venezuelan Government Will Take Vigorous Steps to End the Rebellion.

CARAS, Aug. 1.—In consequence of the outbreak of a revolution in Venezuela and invasion of the country by a force under the leadership of former President Cipriano Castro, the Federal Council today constitutionally authorized President Juan Vicente Gomez to assume dictatorial powers until the movement is crushed. The President has issued orders to the Governors of all Venezuela states to act vigorously against the rebels. The whereabouts of Castro is unknown.

CASTRO BUSY IN VENEZUELA

Deposed President's Followers Said to Be Leading New Revolt in Republic.

WILEMSTADT, Curaco, Aug. 1.—Confirmation of the reported mutiny of the garrison of Coro, capital of the state of Falcon, Venezuela, was received here today. The rebels are in command of the place, and are exercising the functions of the government. All the indications point to the move having been made by the adherents of former President Castro, who is said to control a steamer now in these waters, but which has not yet been reported or seen.

CLOUGH HEAD OF N. P. LINE

First Vice-President Will be Promoted to Succeed Howard Elliott.

NEW YORK, Aug. 1.—Wm. R. Clough, first vice-president and member of the executive committee is to be successor of Howard Elliott as head of the Northern Pacific Railway, according to an authoritative announcement in Wall street today.

Instead of being president, Clough will become chairman of the board of directors, a new office to be created. The office of president will be filled, it is said, by J. M. Hanaford, now second vice-president, whose duties will be confined to the operation of the road. George T. Slade, son-in-law of James J. Hill and now third vice-president, will become first vice-president. Mr. Clough, who is a lawyer and has for many years acted as legal adviser of the Northern Pacific, will have charge of the financial administration of the road, with offices in New York.

MITCHELL FOR GOTHAM MAYOR

Republicans, Progressives and Independents Select Ticket in New York.

NEW YORK, Aug. 1.—John Pursey Mitchell, collector of the port of New York was nominated for mayor today on a fusion ticket by a committee of republicans, progressives and independents organized to fight Tammany Hall at the coming city election. Mitchell is a democrat, thirty-three years old and it is understood that President Wilson approves of his nomination. District Attorney Charles S. Whitman, republican, was defeated by Mitchell for the mayoralty nomination by a narrow margin, and was renominated county prosecutor. Other nominations were: Comptroller, Wm. A. Pendergast; President Board of Aldermen, George McAneny.

WHITE SLAVE CASE DEBATE

Diggs-Caminetti Controversy Ends in Defeat of Kahn Resolution Today.

WASHINGTON, Aug. 1.—The Diggs-Caminetti debate in the house wound up today with republican leader Mann making a hot attack on the administration and Attorney General McReynolds for the postponement of the prosecution and Chairman Clayton of the Judiciary Committee replying with a spirited defense. The galleries were crowded, but Mann minced no words.

"The Republicans have fallen down utterly in their attempt to make a scandal out of this case," Clayton said. "They have not been sustained by facts, so the gentleman from Illinois is adopting tactics of a police court lawyer and weeps his way out of the court." The House tabled representative Kahn's resolution calling for information which the Attorney General already has supplied.

CURRENCY BILL TO PASS SOON

Representative Palmer Predicts That Measure Will Pass House Quickly.

WASHINGTON, D. C., Aug. 1.—Representative A. Mitchell Palmer, president of the House Democratic caucus, was an early White House caller today and predicted smooth progress for the administration currency bill.

"The House caucus," he said, "at its meeting August 11 will adopt the administration bill without material change and will take the banking and currency committee's report quickly to the floor of the House. The bill will be passed and submitted to the Senate just as soon as that body passes the tariff bill. I think the bill will become a law during this session."

DEMOCRAT IS AGAINST TARIFF

Louisiana Senator Says His Duty to His State Greater Than to Party.

WASHINGTON, D. C., Aug. 1.—Senator Thornton, a Democrat, of Louisiana, who will vote against the tariff bill because of free sugar, delivered today an impassioned denunciation of his party's determination to put sugar on the free list. "I owe the people of my state a far higher measure of devotion than I owe to the Democratic party," he said. "Honor and duty alike demand that I vote against this bill while it embodies this provision."

HARD COAL TRUST.
Congressional Investigation of Railroad Control is Urged.

WASHINGTON, D. C., Aug. 1.—An investigation of the hard coal trust was proposed in a resolution today by Representative Murray, of Massachusetts. It calls on the Department of Commerce, the Department of Labor and Interstate Commerce Commission for information as to the ownership of the anthracite lands by the railroads and as to prices and costs of productions.

Russia Said to Have Refused Outright and Germany and England Will Not.

AUSTRIA WILL SEND COMMISSION THERE

Manufacturers Claim That Expense of Exhibits is Too Great—Bryan Hopeful.

BERLIN, Aug. 1.—Although the German Secretary of the Interior declared today that Germany had not yet taken any action in regard to the question of the Panama-American exposition in San Francisco in 1915, the opinion is freely expressed in official circles that the German empire will not be represented there. It was pointed out today that the British government's decision not to participate settles also the action of Germany, as the only factor which might have induced the German government to bring pressure to bear upon the unwilling business men to exhibit was the fear of unfavorable competition with Great Britain. The business men generally declare themselves tired of the expense connected with frequent expositions and say they see no prospect of financial returns should they exhibit at San Francisco.

RUSSIA ALSO OUT.

Decides Not to Have Exhibit at San Francisco Exposition.

ST. PETERSBURG, Aug. 1.—The Russian government decided today not to participate officially in the San Francisco exposition.

AUSTRIA IN DOUBT.

Will Send Commission to San Francisco to Investigate Exposition.

VIENNA, Aug. 1.—A commission of representatives of the Austrian Hungary government and of the local Chamber of Commerce will visit San Francisco and on this commission's report depends the reply of the Austria-Hungary government as to participation in the Panama-Pacific Exposition. The question is largely one of finance. The government hesitates to appropriate a sum sufficiently large to assure representation on a scale commensurate with the dignity of the Empire.

BOOSTER CLUB AT NORTH BEND

Mass Meeting to be Held There Tonight to Organize Chamber of Commerce.

At a mass meeting to be held at the North Bend Commercial Club this evening, steps will be taken to organize a North Bend Chamber of Commerce. The project has been launched by a petition and about 125 have already signed the membership roll so that really the only business remaining for tonight will be to perfect the organization.

For some time past, the North Bend Commercial Club, which was organized at first as purely a social organization, has been looking after the booster work. The plan now is to allow the Commercial Club to resume its old status and form an active Chamber of Commerce which can more systematically and effectively handle the boosting. The members are to pay \$1 per month and this, with special contributions, will maintain it.
