DREW CAMINETTI RESIGNED JOB NIGHT HE LEFT ON RENO TRIP

New Evidence Introduced in Noted San Francisco White Slaves Case Today. CAMINETTI ATTORNEY SCORED BY COURT Judge Van Fleet Rebukes Attorney for Criticising Prosecution of Offender.

SAN FRANCISCO, Cal., Aug. 28.—In the Drew Caminetti white slave trial today, testimony of minor witnesses followed the order taken in the Biggs trial and repeated the same matters. A feature of the morning was a severe rebuke administered to Marshall Woodworth, chief counsel for the defense, by Judge Van Fleet, because of an interjection in a newspaper in which Woodworth said: "It is ridiculous to suppose the law was framed with the intent of making felons of youths like Drew Caminetti. Everybody knows Congress enacted that law for the purpose of checking commercialized prostitution."

FIRE DESTROYS SAWMILL TODAY

Large Mill and Lumber Yards at Friend, Oregon, is Burned. (By Associated Press to Coos Bay Times.) PORTLAND, Or., Aug. 28.—Fire early today destroyed the sawmill and lumber yard of J. A. Olney at Friend, Oregon, and threatened the surrounding forest. The fire seriously crippled a number of box factories in the Western Oregon fruit district depending upon Olney for their materials. Olney last week had two carloads of box lumber burned on the track at The Dalles.

LOCAL LINE TO BE IMPROVED

Re-Ballast Road From Myrtle Point to Marshfield—Get Gravel From New Line. Superintendent W. F. Miller, of the local railway has just completed arrangements for reballasting the line from Myrtle Point to Marshfield. The job will take a few months, but an endeavor will be made to complete it before the rainy season. The work will cost upwards of \$30,000.

They were 87 years old four weeks ago and both are still hale and hearty despite their advanced years.

NO FIRE NEWS

No Fire News.—No additional news has been received from Bay Point or San Francisco relative to the big fire in the C. A. Smith company's yards at Bay Point beyond what was given in The Times last evening. Vernon Smith who is now on the Bay is expecting further details soon. So far nothing has been learned of the origin although some wild rumors have been afloat around the Bay by people who know nothing about the matter. The actual lumber lost will probably be close to \$6,000,000 feet.

BANDON PORT CARRIED BY ABOUT 350 MAJORITY YESTERDAY

Partial Returns Indicate Complete Victory—Big Majority at Bandon and Vicinity Offsets Coquille — Probable Commissioners. (Special to The Times.) BANDON, Ore., Aug. 28.—Nearly complete returns from the special election in the Coquille Valley yesterday indicate that the Port of Bandon carried by a big majority. With the exception of the Bandon precinct, the vote was light, comparatively little interest being taken in it.

Whether arrangements can be made to have the new Port Commissioners elected at the November election is uncertain, if not, Governor West will probably appoint. G. T. Treadgold of Bandon, E. C. Johnson of the Johnson Lumber company of Randolph, Mayor Morrison of Coquille, L. J. Cody of the Cody Lumber company and D. D. Pierce of Coquille have been suggested as probable Commissioners, although others may be brought out.

FIRE SWEEPS LARGEST VESSEL

Blaze Breaks Out in Hold of Imperator, Largest Ship Afloat, at Her Dock in New York Harbor. (By Associated Press to Coos Bay Times.) NEW YORK, N. Y., Aug. 28.—The steamship Imperator, the largest vessel afloat, was swept by fire early today as she lay at her dock in Hoboken with her crew and 1130 passengers aboard.

Second Officer Lohrecht, who led the crew into the hold to fight the flames, was cut off from his men and suffocated. Seaman Otto Strantz, one of the party who went down with Lohrecht into the bowels of the vessel, also perished. A fleet of fire-fighting crafts augmented by apparatus from shore, surrounded the ship and poured tons of water into her hold. When the fire was checked the great vessel had heated fifteen degrees.

Stowage passengers aroused from sleep by the crackling of flames, rushed panic stricken for the pier. None of the stowage passengers had been inspected by the customs or health authorities. Because of this, armed guards surrounded them and the immigration authorities rushed them to Ellis Island this forenoon. Some thought to be dead when found were revived at the hospital. They were seriously injured. Officials of the line estimated that the damage to the vessel itself would not be large. Great quantities of supplies were made useless, however, by flames, smoke and water. Nearly two million gallons of water were poured on the fire. The ship will sail Saturday as scheduled and the damage will be repaired at sea.

TRY TO STOP PRIZE FIGHTS

Los Angeles Church Federation Plans to Submit Initiative Bill to Voters Soon. (By Associated Press to Coos Bay Times.) LOS ANGELES, Aug. 28.—The anti-boxing bill now being drafted by a committee of the Los Angeles Church Federation and which it was announced today, would be presented to the voters of the state as an initiative measure, is said to be the most drastic measure of the kind ever proposed in California. It would limit all contests to four rounds, prohibit the charging of admission fees for spectators and make eight-ounce gloves the lightest that could be used. The Federation will meet tonight to plan an active campaign for this measure, the death of Bull Young in his bout with Jess Willard having aroused a strong sentiment against prize fighting.

CRAWFORD IS NEARLY DONE

Attorney General Practically Completes I. W. W. Investigation — Poor Showing. Attorney General Crawford arrived here last evening from Coquille and left early this morning. He had little to say about the results of the investigation pending the report that he will make to Gov. West. However, parties who have heard the principal evidence given at the public hearings say that nothing has developed that would warrant any action against Sheriff Gage for being delinquent in his duty and Gov. West's principal charges were against Gage. In addition to what evidence has been given that might reflect on Sheriff Gage, it is understood that Sheriff Gage has some testimony that will make some of his accusers look mighty sick, and also put a bad crimp in the damage suits which Dr. Leach and his associates are planning to bring against the City of Bandon and others.

GOOD RIFLE SHOOTING

CAMP PERRY, Ohio, Aug. 28.—Washington and Iowa rifle teams tied for fifth place, with a score of 540, in the surprise fire, first stage of the national team match, today the United States Infantry team being first, with a score of 5, 6, 7.

WOMAN FRIGHTENED

Woman Frightened.—A stranger went to the home of A. O. Haas yesterday noon and badly frightened Mrs. Haas. Mr. Haas is in San Francisco on his vacation trip, being off duty as mail carrier, and she was alone. The stranger used rather insulting language, but finally left and Marshal Carter is looking for him. Neighbors of Mrs. Haas are also on the lookout and if the stranger can be found he will probably be taught a lesson that he won't forget in a long time.

DENIAL BY PERKINS

G. T. Treadgold, of Bandon, this afternoon informed The Times that F. N. Perkins had positively denied telling Attorney General Crawford that J. M. Upton had informed Sheriff Gage in advance of the Leach deportation or in any way connecting Mr. Upton's name with the affair. Sheriff Gage, who was here yesterday had been informed that Perkins was credited previous to Crawford's visit at Bandon about making remarks about Messrs. Upton and Gage, which Mr. Gage says were absolutely untrue.

PRESIDENT HOPEFUL.

(By Associated Press to Coos Bay Times.) WASHINGTON, D. C., Aug. 28.—After an early conference with Secretary of State Bryan and Chairman Bacon of the Senate foreign relations committee, President Wilson let it be known that he believed the situation in Mexico was encouraging. The President thinks things are changing in Mexico City and that something tangible will soon be known.

Dictator Takes New Position in Dealing With United States and Backs Down.

ELECTIONS WILL BE HELD IN REPUBLIC SOON Lind Ordered to Return From Vera Cruz to Mexico City Today—Outlook Better.

LIND TO RETURN.

(By Associated Press to Coos Bay Times.) WASHINGTON, D. C., Aug. 28.—John Lind early today was instructed to return home from Vera Cruz to Mexico City if in his discretion it seemed advisable. The instructions were sent after President Wilson had received a message from Lind which was described as "very thin was alien" as to the next move, the general understanding was that the way appeared open to further discussion of the disputed points, such as the elimination of Huerta.

TRY TO REGAIN EASTSIDE LAND

Heirs of Wm. Hinch Claim East Marshfield Land Company's Holdings Now. A strange mixup has been revealed in Eastside land titles about some deeds that have been filed the last few days. About 100 lots of the East Marshfield Land company are said to be involved.

It seems that the tract of about forty acres near the point originally owned by an old miner named Hinch was later sold by the Sheriff on an execution. Later the East Marshfield Land company in which W. U. Douglas, Henry Sengstacken and others are interested bought and platted the tract and have sold most of it, having only a small portion of the original four hundred lots left. Now, it is claimed, the sale by the Sheriff was void because the legal requirements were not met, no publication of sale being made and the proceedings being in the County Court instead of the Circuit Court. EXPOSITION BUILDING

President Wilson Favours Appropriation for One in San Francisco. (By Associated Press to Coos Bay Times.) WASHINGTON, Aug. 28.—President Wilson took under consideration today plans for the appropriation for a large Government building at the Panama Pacific Exposition, and will confer soon with members of Congress. The United States has appropriated half a million dollars for exhibits. President Wilson expressed renewed interest in the Exposition and hoped that any impression abroad that the affair was a sectional one would be dissipated.

MEXICO CITY, Aug. 28.—In his second communication to Lind, Secretary of State Gamboa says: "If even once we were to permit counsels and advice let us call them thus' of the United States of America, not only would we forego our sovereignty, but we would as well compromise for an indefinite future our destinies as a sovereign entity and all future elections for president would be submitted to the veto of any President of the United States."

EMBARGO ON ARMS.

(By Associated Press to Coos Bay Times.) WASHINGTON, D. C., Aug. 28.—At Secretary of Bryan's request, the Treasury Department telegraphed today to all customs agents to embargo all shipments of arms to Mexico regardless to whom consigned. A large shipment waiting at Juarez will be withheld although a portion already had been allowed to pass.
