BANKS MUST SUBMIT TO CONTROL BY GOVERNMENT NOW

Time Has Come When Bankers Must Accept Situation Says Bulkley.

Harrowing Experiences Related by Survivors From the Burned Liner Volturno—Derelict Still Afloat and is Drifting Toward Land.

FIFTY MORE SURVIVORS. ARRIVE IN LIVERPOOL.
LIVERPOOL, Oct. 14.—The steamer Dovenian arrived here today bringing fifty Volturno survivors on board, many of them remnants of families crazed with grief and terror at the tragedy through which they had passed. Ernest Hermann, who first noticed the fire in the hold, says even then it had made such progress it was evidently impossible to subdue.

VOLTURNO STILL AFLOAT.

LONDON, Oct. 14.—The Volturno was still afloat Sunday in latitude 47.37 north longitude 33.45 West. There is a possibility of the hulk yet reaching land.

MALE PASSENGERS TRIED TO RUSH RESCUE BOATS

LIVERPOOL, Oct. 14.—According to Captain Trant of the Dovenian an attempt was made on the part of the male passengers of the Volturno to rush the rescuing boats when they reached the vessel's side, and the Volturno's captain and officers did good work in keeping them under control.

Trant says the pitiable screams for help from the Volturno made the "night hideous" to the rescuers unable to give aid.

When the Dovenian was able to launch boats the women and children were taken first. They were swung over in coal baskets and lowered to the boats.

Crew Cowardly and Brutal.

LONDON, Oct. 14.—That the crew of the Volturno, most of whom were Dutch, behaved in a cowardly manner and were brutal to the passengers, is the verdict of most of the thirty survivors who arrived at Gravesend on the Minneapolis today. All survivors were Russians, Hungarians and Poles.

NO CHANGE IN CANAL ZONE

Control and Operation to be Left in Hands of Isthmian Canal Commission.

WASHINGTON, Oct. 14.—Until the commerce of the world actually is flowing smoothly through the Panama Canal, no change in either the operation of the big ditch or in the government of the canal zone will be made. This became known today.

It developed also that through this decision President Wilson planned to pay a delicate compliment to the men who have accomplished the herculean task of joining the oceans by giving them an opportunity to enjoy the fruition of their labors. Congress provided for a civil government for the zone, but for the time being its control is to be left to the Isthmian Canal Commission and army engineers.

TRAPPED IN BURNING MINE

Entrapped in Burning Mine—Rescuers Are Working Desperately.

CARDIFF, Wales, Oct. 14.—More than 400 Welsh coal miners are believed to have perished in the Universal Colliery near here today. A terrible explosion of gas shattered the works shortly after 7:40 when 931 men went down the shafts. Five hundred people had been rescued by noon when fire broke out and halted the work of rescue.

CARDIFF, Oct. 14.—All the men in the east side of the mine reached the surface by six o'clock, but 418 are still in the workings on the west side, which is on fire.

Colonel Pearson, the mine inspector, said: "The fire is in the intake airway and everything is being done to cope with it."

REDONDO SALE IS NOT CLOSED

Two Weeks' Option on Vessel Has Expired—Consider Changes in Nann Smith.

The option on the Steamship Redondo, which was held by some San Francisco brokers, has expired and it is not likely that the sale will be consummated. Arno Meezen of the C. A. Smith company, who arrived here yesterday said that the company was disinclined to sell the vessel, but as a very good offer had been made and the people were so urgent about it, a two weeks option was given.

The Nann Smith is now being held at San Francisco to secure some estimates on some changes in the vessel which they have under consideration. It is a little indefinite yet as to the nature of the changes and just when they will be made.

Mr. Meezen said that they were anxious to furnish better service for the Bay and hoped to arrange it shortly.

Mr. Meezen said that they were looking things over here and it would probably be two or three days before they would get closely in touch with matters.

The lumber market shows little change with the exception that the demand is some better. The prices continue very low.

HITS OFFICER; IS BOUND OVER

JACOB BECKLER PROVES REAL SCRAPPER AND INJURES LEVI SMITH WHEN RESISTING ARREST—SUSPECTED OF OTHER OFFENSES.

John W. Beckler was this afternoon bound over to the grand jury by Justice C. L. Penneck on the charge of assaulting and resisting Officer Levi Smith. His bail was fixed at \$500 and in default of it he will be taken to the county jail at Coquille tomorrow morning by Constable Cox.

Beckler looked "second best" while he was trying his own case before Justice Penneck this afternoon. One eye was black, swollen and otherwise marred; his shirt collar was still bloody and he was rubbing a gash in his head.

Officer Levi Smith, who appeared against him is still suffering from a badly swollen and bruised jaw and is nursing some other bruises inflicted by Beckler.

The fracas occurred in the P. K. saloon last evening. Fred McClees and Mr. Brown, the bartenders, stated that following some one being accused of trying to pick somebody else's pocket, Beckler started trouble and wanted to fight. They sent for Officer Levi Smith and Beckler refused to go with him. Smith sent for aid and Shoupe and Carter responded, and Beckler was still fighting. They finally tied his arms and started to drag him down the street. Beckler had hurt Shoupe's wrist and he turned his hold over to Gordon Smith and just then Beckler, wrenched around and arising on his shoulder, kicked Smith in the jaw.

When arraigned this afternoon, Beckler demonstrated that he had a pretty good education, some knowledge of law and evidently had been in court before.

Think Him Bad One. The police say that Beckler is one of the worst men who has been here recently. They did not get his right name, or what is presumed to be his correct name, until they found a receipt from the Panama Employment agency at San Francisco issued August 6 to John W. Beckler to work for the Brookings Lumber Company at Chico.

Suspended Provisional Constitution and Will Issue Decrees From Time to Time

TO MAKE "INTEMPERATE" REPLY TO NOTE FROM U. S.

Huerta's Proclamation Considered by Cabinet at White House Today.

REPORT OF AMERICANS ATTACKED BY MEXICANS
EL PASO, Oct. 14.—F. B. Ellis arrived today at Juarez from Torreon. He says that his brother, Joe Ellis, was killed by rebels while a party of Americans, of which he was a member, was leaving for the border. Three of the party is missing. They are: J. M. Parsons, Wichita; L. M. White, Butte; A. T. Stevens, Sacramento. The party was half way between Torreon and El Oro when attacked by a body of Mexicans.

MEXICO CITY, Oct. 14.—An early answer is to be made by the Mexican government to the communication from Washington stating the United States would look with displeasure on any injury to the Mexican deputies under arrest, according to the Mexican Foreign Minister, Quoride Mohono.

Mexico's reply probably will be delivered today to Nelson O'Shaughnessy, American Charge d'Affairs.

Neither O'Shaughnessy nor Foreign Minister Mohono would discuss the terms of the note, but Mohono described it as "intemperate."

HUERTA'S DECLARATION RECEIVED AT WASHINGTON

WASHINGTON, D. C., Oct. 14.—Copies of the proclamation by Provisional President Huerta announcing himself dictator over Mexico were received today by the State Department and considered at a cabinet meeting at the White House. Huerta declares he suspended the provisional constitution which grants immunity from arrest to members of the Mexican Congress and announces he will from time to time issue executive decrees because of the dissolution of Congress.

"APPLE DAY" FOR OREGON

WILSON DENIES RYAN'S \$10,000

And Underwood Strikes From His Speech of Yesterday His Reference to Contribution.

WASHINGTON, D. C., Oct. 14.—Democratic Leader Underwood's reference in the debate with Representative Hobson yesterday to Thomas Fortune Ryan having contributed \$10,000 to President Wilson's campaign fund, when the President was running for Governor of New Jersey did not appear today in the official report in the Congressional Record.

The White House informed Underwood that no such contribution had been received and the Democratic leader struck out the reference from his speech before the Record went to press last night.
