Resume of New Factories and Extension of Trade and Building Over State
(Prepared by the State Bureau of Industries and Statistics.)
SALEM, Or., March 11.—Woolen manufacturers at Cologne, Germany, are seeking to contract for the Oregon grown teal and that industry is reviving.
Catholic people at La Grande are planning a \$30,000 cathedral.
The Milton box factory is being enlarged to 500,000 capacity.
A logging company at Knappa will extend its railroad three miles.
The Eugene fruit growers' association has orders for \$10,000 of their 1914 product.
West Linn, Clackamas county, will erect a \$15,000 city hall.
Sherwood is to have a \$10,000 hotel and bank building.
Springfield and Hood River have stock subscribed for canneries.
The Wilbur Woolen Mills at Stayton will be enlarged and a warehouse and mattress factory added.
The Everfresh Food Products company at Sutherlin will enlarge its plant to double capacity.
The Rainier Mineral Soap factory at St. Helens has made arrangements to operate this year, starting this month.
The Booker basket factory at Hillsboro will be enlarged and add a line of wicker chairs.
Kimball cultivators manufactured at The Dalles are shipped east by the carload.
The people of Turner voted to install a supply of pure spring water.
The state and Federal commissioners on development of The Dalles water power project visited the grounds the past week to select a site.
The Eugene excelsior plant will double its plant and in a new fire-proof building hopes to have a payroll of \$10,000 within a year.
Lane county manufacturers meet Tuesday, March 10th, to consider a state industrial convention and county exhibit.
A \$20,000 office building will be erected at Baker City for Louis Sommers of Portland.
The Swedish Lutheran church of Portland will erect a hospital.
The Eugene iron works is planning to begin the manufacture of a portable range for mountain and military purposes.
Among new brick buildings for 1914 are a school house at Silverton and a city hall at Woodburn.
Corvallis Odd Fellows plan the erection of a three story temple.
Molalla is to have a \$25,000 electric power plant.
Two concrete business buildings are going to be built at once in Eugene.
Veatch Brothers of Cottage Grove will erect a new store building.
The attorney general sustains the injunction suit of the Employers' Association against running the state printing office as a closed shop, but holds the state can pay the union scale of wages.

EUGENE—Public school students are planning to organize garden clubs.
PEEL—Chas. Serfling killed a big cougar in the cabin on his homestead near here.
ROSEBURG—The Council ordered East Sixth street paved after a long controversy.
ALBANY—Albany will have a big storage and packing concern managed by the Suddell brothers.
EUGENE—Work will begin on \$100,000 worth of extensions of the municipal water system soon.
EUGENE—Ed Thayer, a switchman, has refused an offer of \$35,000 for a patent hot water contrivance.
ROSEBURG—L. E. Milledge sold his interest in the grocery firm of Milledge & Pickens to O. H. Pickens.
WOODBURN—The Tribune has suspended and the plant will be moved to Portland and used as a job office.
ASHLAND—The Ashland lodge of Elks has 600 members, and is now the third lodge of the order, in membership, in the state.
OAKLAND—Walther Alderson of Chicago was kicked off a freight train by a brakeman while beating his way and was killed.
LEBANON—The city council made six new ordinances at a meeting held recently. The majority of these laws hit liquor and tobacco.
CORVALLIS—C. J. Buck of Benton county, who created some disturbance in Corvallis recently, has been committed to the state asylum.
CORVALLIS—A. L. Martin, manager of the Oregon Power company, has gone to Dallas to take charge of the interests of the same company there.
ROSEBURG—Fred Martin, arrested at Chico, California, for having robbed the Shasta Limited and other trains near here two years ago, proved an alibi and was released.
INDEPENDENCE—W. J. Lynott has imported from Wisconsin a carload of thoroughbred Holstein cattle consisting of twenty-six cows and one bull. The lot is valued at \$10,000.
ALBANY—Mayor Carl has resigned his position as chairman of the Linn county Republican central committee and will devote his time to administering the affairs of Albany.
EUGENE—Mrs. M. E. Thompson's clothing caught fire when a lamp overturned and the only thing she could find to extinguish it was home-made beer. She saturated herself and the beer probably saved her life.
PORTLAND—A smart thief secured the keys of a furnished house, representing that he wanted to purchase it. He at once got busy and sold all the furniture. Up to date he has not been discovered.
EUGENE—The O.-W. R. & N. has presented a site for a medical college to be used as a campus for the U. of O. college building which is to be erected in the near future. The tract is valued at \$100,000.
ROSEBURG—The county court refused to call a special election to allow Edenbower to vote on incorporating because the petition lacked one of being sufficient, C. Schmidt, one of the signers, not being naturalized.
EUGENE—Jesse Godlove met with a serious accident near Springfield while riding his motorcycle. He was going a thirty mile clip when his motor refused to take the turn in the road and he was dashed against a telephone pole and his right leg was broken near the hip.
BAKER—The epidemic of hydrophobia in Baker county is unabated. Several coyotes and dogs afflicted with the disease have been killed recently, and vigorous efforts to stamp it out are being made. This is extremely difficult on account of the coyotes having the disease and communicating it to each other. Nearly every day there are reports of the killing of mad coyotes, and generally after they have bitten dogs or stock.

STOP LIQUOR SALES
Governor West to Have Licenses of Offending Druggists Revoked
SALEM, Or., March 12.—Stating that he has been informed that a number of druggists in the state are "bootlegging," the Governor announced that he has asked the State Board of Pharmacy to meet on April 1, and provide regulations whereby any druggist, apprehended for violating the liquor law, may have his license taken away from him. Under the law, the board can make such regulation, he stated.
RUSH CANADIAN RAILWAY.
The desire is so eager for completion of the Grand Trunk Pacific that the men, some 5000 in all, are working all day on Sundays, with night shifts all the time. The people along the line are eagerly awaiting the completion of the whole Grand Trunk Pacific, which, whatever be the arrangements with respect to the eastward section, would find business to hand at once. Many individuals and companies are staying their hand from new enterprises until the steel is all linked up—east and west—when they will take off their coats to big undertakings.

WAITE'S NEW PLAN.
Will Put In Big Gravel Plant Near Roseburg.
A Roseburg paper says: "The good roads movement will no longer suffer from a lack of good gravel at a cheap price. Frank B. Waite, the Sutherlin capitalist, and G. T. Larson, formerly construction engineer for the Bylesby Company of Chicago, perfected arrangements for the construction of a modern gravel plant to be located at Shady Point about two miles south of Roseburg. The Southern Pacific company will put in a spur to the plant and some time this spring gravel will be shipped to various points.
Electric hoisting devices will pull the gravel from the bed to the plant and similar devices will load the gravel into the cars. The capacity of the plant will be about thirty cars a day and the cost of erection will be around \$20,000.

CURRY MINE PLANS.
Ed A. Zimmerman of Eden Valley, which lies south of Canas Valley and is reached by the Gold Beach trail from West Fork, leaves for his mines in that locality tomorrow. Mr. Zimmerman says that there is every prospect for great mining development in that section. Stamp mills are in course of construction and much preparation is being made to work the mines at once.—Roseburg News.

UMPUA LOGGING ROAD.
