BOZEMAN AND BILLINGS TO LAY MORE BITULITHIC

Bozeman, Montana, last year laid 60,000 square yards of bitulithic pavement and Billings, Montana, laid over 20,000 square yards, and the property owners of both towns were so pleased that the Council decided on bitulithic as the standard pavement for this year.

After making a careful study of paving materials, bitulithic is being used extensively, as it has been found to be lasting and economical and especially easy on horses and automobiles.

Its past record in many northwestern cities shows it to be well suited to the climatic conditions of this section, which is a matter of importance in choosing paving.

SHOPS AT SPRINGFIELD

Southern Pacific Buys \$18000 Tract For Yards There.

The Eugene Guard says: Eighteen thousand dollars will be paid by the Southern Pacific company or to be more exact, the Oregon and California Railroad company, for forty-six acres in Springfield purchased as a part of the site for the construction of machine shops, according to Judge William M. Colvig, Southern Pacific right-of-way and tax agent. The land was sougat a year ago, when machine shop plans were talked of with but little reserve. The purchase has been litigated a year, and was completed, according to Judge Colvig.

The property was purchased from Emilia A. Smith, husband, and heirs of the Brattain estate.

The sale indicates that the railroad company has not abandoned its plans for developments in Springfield. Local engineers admit that, although plans for the immediate future have been killed by the present financial situation, and also by the difficulties of the railroad unemerging the Springfield yards stand before the railroad company as one of its first projects, but which also hangs largely upon the completion of the Oregon and Eastern by the Natron cutoff. The railroad company already owned sixty-five acres in Springfield before the purchase.
