BAD CHECK TO CAL WRIGHT

WARRANT ISSUED FOR JOHN SHALEY WHO IS SUPPOSED TO BE AT BANDOON—ISSUED \$10 WORTHLESS CHECK.

Cal Wright of the Claymore Bar today swore out a warrant in Justice Penock's court charging John Shaley with obtaining money under false pretenses. The warrant was sent to Sheriff Gage, as Shaley is supposed to be in Bandon. The check was for \$10 and was drawn on the Hartman-Thompson bank at Portland. It was returned marked "no funds." Shaley worked around restaurants while here.

Forged Check for License. County Clerk Watson is reported to have been "stung" a few weeks ago when he accepted a check from Ed Smith for a wedding license. Smith also cashed a couple of more worthless checks on the mill boarding house man at Porter. He was taken before the grand jury but on promise to make the checks good was released.

PLAN RAILWAY TOWARD BAY

Roach Timber Company, Weyerhaeuser Interests and L. F. Luse in Project.

PORTLAND, Or., May 1.—Agreements signed in Portland between the representatives of the Roach Timber Company, the Weyerhaeuser Company and the J. F. Luse Company, of Sutherlin, settled the first steps in the construction of the Sutherlin, Coos Bay & Eastern Railway out of Sutherlin eastward to tap the big timber belt lying twenty-seven miles from that city.

Representatives of the eastern concern who were in Portland yesterday were W. L. Roach of Muscatine, Iowa, C. M. Crego of Spokane, and William Muser of Iowa City, who represents the Weyerhaeuser interests. F. B. Waite and J. F. Luse, of the J. F. Luse Company, of Sutherlin, were the local parties to the agreement.

The engineer will be secured immediately and construction on the road will be put under way as quickly as possible, it is reported. The first unit of the road to be completed will be twenty-seven miles that will run eastward from Sutherlin. Later it is contemplated to extend to Coos Bay and run into the interior of the state. The immediate aim of the company is to provide for the development of the 54,000 acres of timber east of Sutherlin. Mills for handling this timber will probably be established in Sutherlin.

HOPE TO GET STARTED SOON

Dan Conlogue Expects Camps and Mill at Bandon Will Start Within 3 Months.

Dan Conlogue of the Conlogue Logging Company was in Marshfield today en route to his old home in Pennsylvania, where he will visit for a couple of months. He stated that the Moore mill at Bandon had closed down as a result of the controversy between the Moore Company and the Coach Estate over timber. The Conlogue camp was closed down some time ago. Mr. Conlogue said that he was in hopes they would get matters all straightened out so that they could resume operations inside of three months. The litigation between the Moore company and Coach Estate will probably continue much longer unless some sort of a settlement is reached. Regarding the report that the company was taking over the Boutin tract of timber and would have the Conlogues move their logging outfit to the Beaver Slough section, Mr. Conlogue had little to say. He said that he and others had been busy the last few weeks cruising timber and looking it over with a view to getting things lined up for the future.

May Close Mill. Mr. O'Toole who came over from Bandon yesterday and is enroute to Portland said that he had been informed that the Sudden & Christenson Lumber Mill at Prosper planned to close down soon for a time until the lumber market improves. He said that Mr. Moore of the Moore Lumber Company had informed him that the Moore Lumber Company would start up within two weeks if it was victorious in its suit with the Coach Estate at Coquille and if it was not, they hoped to move their logging equipment soon to the Boutin tract and get things going.

COUNTY BLDG. NOT IN FAVOR

Panama Exposition Authorities Have Rule Barring Exhibits by Counties.

The following form the Bandon Recorder places the plan to have a Coos County building at the Panama Exposition in San Francisco in a strange light: Those who were hoping to have a Coos county building at the Panama Pacific exposition are doomed to disappointment according to information received by the Commercial Club. All exhibits must be made in the main exhibit places. This will be a great disappointment to Coos county people who have hoped to do some extensive advertising of this section at the fair.

It will now be necessary to devise other means of advertising than that at first planned. The following letter from the Director of the Exhibits of the Commercial Club explains the position of the exposition officials.

"Bandon Commercial Club—I am duly in receipt of your communication of April 14th in which you request us to give you certain information with regard to the exhibit of Bandon, the Coquille River and Coos county at this exposition. In reply, I beg to inform you that all exhibits will have to be made in the main Exhibit Palaces. The Oregon building will contain no exhibits for award, and only displays not to be viewed by the jury will be installed therein. Even if you succeed in erecting a building for Coos county you would not be allowed to make your exhibits from that county in this building."

"If you will inform me as to the exact nature of your exhibit, I will then be able to refer you to the various Departmental Chiefs under whose jurisdiction such exhibits fall. I have referred your inquiry as to the use for decorative purposes on the exposition grounds of Coos county myrtle and Port Orford white cedar shrubbery to the Director of Works who has jurisdiction over this portion of the work. I appreciate your interest and welcome your co-operation. Very truly yours, A. C. Baker, director of exhibits."
