The generation of today has not forgotten and generations yet unborn will not forget, the valiant acts of these men. Unto them the country will ever be grateful. But the last resting places of those who participated in the tremendous struggle through purely patriotic devotion shall never be forgotten.

UNIVERSITY OF OREGON WINS. The University of Oregon won highest honors at the conference athletic track and field meet held at Pullman, Washington, with 34 points. The Oregon Agricultural College was second with 27 points. Washington State College, third, 26 points; University of Washington is credited with 22 points; University of Idaho, 19 and Whitman College, 6. The conference record in the 4:40 and 8:30 yard runs and the high jump were broken. Stuller, of the University of Oregon, jumped six feet 1.25 inches.

TWO OF CREW LAND IN JAIL. Peter Oleson, captain of the Schooner Rustler, and John Takkins, mate of the craft, were taken into custody last night by officer Doane and charged with drunkenness. Officer Doane was unable to escort Captain Oleson and Takkins to the jail alone and started blowing his whistle for help. Officer Walter Richardson responded, and with him a large crowd gathered, in front of the Palace Restaurant to witness the affair. Both offenders were released ten minutes after their arrest by depositing \$10 cash bail.

Immediately after his release, Captain Oleson, who has never been arrested in Marshfield prior to this time stated that he was not disturbing Doane, having simply started for the Palace Restaurant to feed his crew and self, when he was met by Doane who put a hand to his shoulder and started dragging him. Captain Oleson says that he was taken unaware and did not understand why he should be arrested without provocation. He also stated that he had a few drinks. Officer Doane states that he had told Captain Oleson to go to bed earlier in the evening, and because of his refusal, more than his intoxication Doane arrested him. Immediately after the arrest, Officer Doane gathered a list of witnesses of the arrest anticipating some trouble when the matter is brought up before Recorder Butler today.
