The light-house tender Manzanita will be fully loaded at Astoria tomorrow and leave Monday for Puget Sound and relight the buoy on arrival."

INDIAN ESTATE PROBATED.

Last of Umpqua Bequeaths \$500 to Niece. EUGENE, Aug. 5.—One of the final chapters in the history of the once numerous tribe of Umpqua Indians who roamed the hills of western Lane and Douglas counties years ago, was enacted in the probate court when the estate of Betsy Wilson, widow of the late Williams Wilson, a prominent member of the tribe, was probated. In the petition for probate it is stated that Betsy Wilson, who died January 2, 1908, was about 100 years of age, and that she left property valued at \$500. Her only heirs are Abbie B. Marshall and Ellen Barrett, her nieces, both living on the lower Siuslaw.

FIRE AT EUGENE.

EUGENE, Or., Aug. 5.—Fire completely destroyed the boarding house of Mrs. L. B. Denny at the corner of Second avenue and Jackson street. L. B. Denny, a paralytic sleeping on the lower floor was dragged from his bed, where he lay helpless, and hurried to a place of safety as the flames entered his bedroom. All efforts of the firemen to control the fire were futile and the house was reduced to ruins.

BOOZE AT FLORENCE.

COTTAGE GROVE, Or., Aug. 4.—Thrown under the wheels of a wagon loaded with wood and the top of his head crushed in, the five-year-old son of Mr. and Mrs. Max Dorward met almost instant death. The family had attended the Christian church Sunday school picnic. After returning home Mr. Dorward went to the woods for a load of wood. In returning with the loaded wagon a snag was struck that threw Mr. Dorward and the boy from the wagon with the result already stated. Mr. Dorward was also run over and suffered a severely crushed leg.

SUSLAW IS DEEPER.

Funds for Harbor Work at Florence Nearly Exhausted. FLORENCE, Ore., Aug. 4.—Funds now available for the work of the Siuslaw Harbor Improvement will be exhausted this fall, but it is hoped that another appropriation may be provided so that the work may be continued. This project was commenced by the government twenty-two years ago and a jetty constructed on the north side of the river, the work being abandoned ten years later.
