School Notes

The superintendent of schools and Principal Waite will keep office hours at the High School building Thursday and Friday afternoon September 10 and 11 from one to five o'clock for consultation on school matters.

Pupils new to the schools will be assigned to classes and grades at the superintendent's office. They are asked to call on the above day and receive assignment to classes. Former pupils of the school who know their classification definitely are urged to purchase school supplies early.

All former pupils of the school are asked to go to the same school they attended when school closed in June. Requests for change of school can be considered later.

Pupils six years of age and over are eligible to admission to school. The compulsory school age covers the period between the ninth and the fifteenth birthdays.

The daily school hours are the same as last year: The High School and eighth grade beginning at 8; the grades at 9 o'clock.

Seventh B pupils of the South Marshfield Schools who share the room with 8 A will report at 8 o'clock on the 14th.

The text books will be the same as last year, except Elson II in sixth grade, costing 50c; Kimball's English Grammar in eighth grade, 45c; Music Reader No. 1 in third and fourth grades, 30c; Music Reader No. 11 in fifth and sixth grades, 30c; Music Reader No. 111 in seventh and eighth, 35c.

COUNTY WILL PASS ON IT

Chamber of Commerce Decides to Have All Unite on Frisco Exhibit—Curry In

There was a fair attendance at the regular meeting of the Chamber of Commerce last evening and after a discussion it was decided to recommend a joint exhibit from Coos and Curry counties to be placed in the Oregon building at the Panama Pacific Exposition in San Francisco next year. President McLean was authorized to appoint a committee, of which he is to be chairman, to confer with like committees from the several commercial organizations of Coos and Curry counties. A meeting of this joint committee will probably be held in Coquille some day next week. They will later appear before the county court to ask that an appropriation of \$1000 for this year and \$1000 for next year be made to aid in collecting the exhibit. Attorney J. C. Kendall was present and reported that on his recent trip through Curry county he found the sentiment there very favorable to a joint organization and that Curry county people were willing to share their part of the expense.

This committee will have charge of selecting someone to collect and supervise the exhibit. No announcement of plans has been made as yet. The petition of J. A. Ward, who wishes to do the work, was presented last night.

To Clean Up City. The committee on advertising, composed of F. A. Tidgen, A. T. Holmes and Dr. G. W. Leslie, are fathering a movement to have property owners clean up their yards, clearing them of weeds, debris, etc., also to have the recently filled property rid of logs, stumps and old lumber which has accumulated on it. A resolution was passed endorsing their work and a copy of the resolution was ordered sent to the City Council. The committee will probably appear before the Council and ask that something permanent be done to insure a cleaner city. Something in the nature of a weed ordinance such as other cities have passed will be urged.

Secretary Motley asked for leave to take a short vacation of two weeks, which was granted. He will spend a part of the time in a hunting trip, while the remainder he will devote to improving his residence property on North Second street.

Mr. J. Wright Wilson presented a proposition to the Chamber of Commerce to paint views of Coos county scenes, 12x6 pictures to be made a feature of the exhibit. It was referred to the exhibit committee.

Among the graduates living here are Miss Genevieve Songstacken, Mrs. Robert Kellogg and Mrs. M. C. Maloney. Former students are Mrs. Arthur McKeown, Mrs. Claud Nasburg, Miss Geneva Wilcox and Miss Georgene Zimmer. Mrs. Kenneth Perkins of Bandon and Miss Jessie Tupper, formerly of Coquille, were also former students. Mrs. S. C. Endicott of Bandon, formerly Miss Audrey Bridges, attended school there, also Mrs. Helen Chandler Tremaine and Mrs. Grace McCormac French.

The building was erected in 1890 and was of red brick. The lawn and surroundings were particularly beautiful, large trees bordering the walks. The estimated loss by the fire is from \$50,000 to \$75,000 and the insurance carried was \$54,000. It is not likely that the school will be rebuilt at its present location as the property has become very valuable, being situated in the heart of the city. The trustees purchased a site for a building in the suburbs of Portland about five years ago and it is likely that this will be utilized for the erection of new and modern quarters. Other than the kindergarten department, which will be held in the gymnasium, the school will not reopen this year.
