

CLAIM WITNESS SPIRIT AWAY

J. Miller, an Austrian, Prosecuting Witness in Gambling Case Gone.

Disappearance of J. Miller, an Austrian and prosecuting witness, was the subject of a hearing against seven Greeks and Gus Delos, proprietor of the Greek coffee house at 165 Front street North, who are now in jail charged with conducting a still in the course of business. The men were arrested in a raid on the house after the men had been overhauled and seized upon.

That the defendant has tampered with the prosecuting witness is the charge of Assistant City Attorney John Kenall and in return C. A. Phillips, one of the attorneys for the defense, declares the city has insufficient evidence for conviction and has taken this means to let the case go.

Joe Loh, a Serbian, and one of the men arrested to have witnessed the games in the coffee house, is being held in jail as a witness for the prosecution. He has put up \$5 bonds to appear at the hearing yesterday morning. The man disappeared and Chief of Police Carter searched the Pioneer Hotel and there found the man, who was immediately taken to jail.

J. Miller is the man who made the Greek coffee house. He was to have been paid \$25 bonds to appear at the hearing. It is claimed that a robbery occurred in the Greek coffee house where he is of last night and this, the defense declares, was done by Miller and this is the reason why he left the scene of the still.

Folle, on one of the days, Assistant City Attorney Phillips has placed a second charge of tampering against the seven men and this trial will be held tomorrow morning before Judge Peters in the police court. A jury will then be selected. The case is to be heard the first gambling case, which now will come up on Friday, and D. A. Jones, J. O. Langworthy, C. M. Parsons, Ivy Condon and Harry Bradford.

By this distance the police have warned every driver and boatman in every direction to be on the lookout for Miller. It is believed that about ten men have been made to tamper with Joe Loh, the second witness against the Greeks and this explains the tampering several days away from the still in the jail.

WINTER CONSTRUCTION WORK

Construction Work on Willamette Pacific Not to Shut Down This Winter

That the construction over the entire Willamette Pacific will probably not be shut down all this winter, was the statement made here last evening by Grant Smith, of the contracting firm of Porter Brothers, despite the rainy season efforts will be made to carry the work through to its earliest completion.

Grant Smith, of Seattle, accompanied by Swan Benson, a large subcontractor on the line, tramped over the new line construction from Glendale to Coos Bay. Both men expressed themselves gratified with the work now being done. But 625 feet remain to be completed on the big 4,500 foot tunnel above Ten Mile lake and this will be finished before other parts of the railroad declared Mr. Benson.

DEMANDS COOS BAY POTATOES

For the purpose of looking over the potato crop of the Coos Bay territory, Claude C. Thompson, representative of the Hood River Exchange, is in the city. Should he be able to obtain about fifteen carloads or about 6000 sacks he declares it is highly probable that the business of transportation would be given to one of the large transoceanic boats through the Panama Canal, as the crop would be marketed in Texas, at present the best potato market in the United States.

Throughout the Northwest the potato crop, reports Mr. Thompson, is medium this year, but the absence of capital on account of the European war is making it impossible for some of the larger commission firms to buy more than enough of the crop to satisfy present needs. They are making no preparations for the winter.

Under this condition most of the farmers are selling for what they can get on the market and the result has been the lowering of the general price. Potatoes that several weeks ago brought as much as \$1.50 on the Portland market are now selling for 95 cents.

That the agricultural products of Coos Bay do not at the present time justify the installation here of a branch house of his company is the decision of Mr. Thompson, although he declares the time is soon coming when business will justify it. Meanwhile he is looking over the potato market in search of 15 carloads for shipment to Texas. Oregon potatoes at present shipped by rail to Texas come high, as the rate is 75 cents per 100 pounds, while by water it would be 20 cents.
