John C. Merchant Insists That City Retain Highway to the Waterfront

Editor Times: While the question of the so-called Ferry Avenue is uppermost, I wish to address a few lines to the public which may lead to a clearer appre-

clation of the value of this street. As the matter now stands, the City Council, having instituted condemnation proceedings to acquire a right-

of-way across the Willamette Pacific railroad at Ferry avenue, appointed a committee to appraise the value of such right-of-way. The committee reported a valuation of \$2000 and

the Council at its last meeting expressed in an informal manner their opinion that this is too much and seem inclined to trade the new street

or at least an essential part of it for ground elsewhere. It seems to me that of all the

blunders possible to be made at the present time, the one most difficult to repair would be to trade away the fifty-foot strip of land extending from Broadway to the harbor line.




